She plans to distribute signs at candidate's forum and will give signs and flyers only to candidates. Colette will notify the candidates by email to offer them to candidates first. The election is May 1. Discussion about how to explain boundaries to poll workers. Four paid poll workers at the election including Ivan Spiegel. Two additional paid workers will be recruited by GWNC.

Candidates will be announced and given a few minutes to speak then follow up with a meet and greet opportunity. find a portable one. Joe will contact the council offices. A volunteer is needed to get water and refreshments and table cloths.
