- **E.** Update on Larchmont Buzz advertising (Fuller) Liz showed updated artwork, received suggestions for minor revisions. Liz will make changes and submit to Buzz asap so we can spend the money budgeted and approved in this fiscal year.
- **F.** Update on migration to MailChimp mailing list service (Hoffman/Fuller) Joe said he hopes to be able to do this soon; should be able to use free account.
- G. Inquiries about possible meeting speakers:
  - i. Fred Pickel (approved at April meeting) (Fuller) With meeting agendas full with budget discussions at the moment, Ms. Fuller suggested holding off on any guest speakers for a couple of months. Others agreed.
- H. Budget planning/possible new expenses for FY 2015/2016 (Fuller/Carroll) Suggested amounts for Outreach items:
  - i. Larchmont Chronicle advertising \$4080.
  - ii. Larchmont Buzz advertising \$1200
  - iii.Larchmont Ledger advertising previously voted to wait a year
  - iv. Promotional items (large banner/graphic, yard signs) \$500
  - v. Printing costs for award certificates \$100
  - vi. Community forums ??

Liz noted that if we budget \$20,000 for an administrator, as discussed at the last board meeting, and we have \$4000 in fixed costs for meeting spaces, and about \$3,000 in photo copies, that comes to at least \$27,000 just for administrative costs. Outreach items above total \$6180, which just is a total of \$33,180 out of our total \$37,000 budget.

Stakeholder Cay Chuco announced an upcoming fundraising brunch at the Cathedral Chapel of St. Vibiana (on La Brea) to raise money for a water pump for typhoon

survivors in the Philippines.

Patti Carroll described a publicity event she attended for the Great Streets Challenge Grant program. The city is giving out \$10,000 grants for projects that would enhance the Great Streets improvements. She noted that they're really asking the applicants to provide much more than \$10,000 in professional-level planning services for that price, but it could still be an interesting project for someone in our area. NCs are not allowed to submit applications, but they can partner with other kinds of applicants. Ms. Carroll suggested discussing it with members of our GWNC neighborhood associations closest to Western Ave. (the "Great Street" in our area). There was also some discussion of whether this effort might be putting carts before horses, since more basic fixes like streets and sidewalks would be necessary before fancier items like shade sails are considered.

Ms. Carroll also expressed concern over the old issue of Koreatown borders (and making sure they stop at Western Ave.), and said she would talk to GWNC Board Member Jane User about putting together a GWNC statement or position paper on the issue.
