**1. Call to Order**

A duly noticed meeting of the Greater Wilshire Neighborhood Council's ("GWNC's") Outreach Committee was held on Saturday, May 31, 2014, at the Bricks & Scones Café, 403 N. Larchmont Blvd., Los Angeles. Committee Chair Fred Mariscal called the meeting to order at 9:13 a.m.

Ms. Savage suggested reaching out to our individual Neighborhood Associations and asking them to identify their "Top 10" issues for their areas, to help us focus outreach and activities for the GWNC.
