

Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, January 9, 2019 Approved February 13, 2019

I. WELCOMING REMARKS (Owen Smith)

A. Call to order (Owen Smith – President)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held on Wednesday, January 9, 2019, at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles, CA 90005. Secretary Max Kirkham called the meeting to order at 7:11 p. m.

The Pledge of Allegiance was led by Max Kirkham.

C. Roll Call (Max Kirkham – Secretary)

The Secretary called the roll. Fifteen of the 21 Board Members were present at the Roll Call: Scott Appel, Tucker Carney, Jeffry Carpenter, Patricia Carroll (Treasurer), Philip Farha, Michael Genewick, John Gresham, Max Kirkham (Secretary), Bobbie Kumetz, Caroline Moser, Tammy Rosato, Steven Senigram, Conrad Starr, John Winther and Greg Wittmann. Charles D'Atri, Karen Gilman and Owen Smith (President) arrived later. Bradley Jewett had resigned and automatically been replaced by Alternate Ms. Rosato [see Item #V. B. i.]. Frances McFall, Julie Stromberg and James Wolf (Vice-President) were absent and not represented by an Alternate. The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 3/5 of the 21 filled Seats, or 13 Members (see the Bylaws at https://lacity.quickbase.com/db/bj3apxsp3?a=q&qid=32&qskip=0&qrppg=1000&dlta=su4 6~), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). No Board Seat was vacant. Five Alternate Seats were vacant [see Item #VI. A.; to apply see www.GreaterWilshire.org]. A. Report: on the January 5, 2019 Committee Meeting

Mr. Kirkham indicated for Ms. Paige that the Committee did not have a quorum for a meeting but did discuss the Homeless Count and more.

- B. Election Update: (Max Kirkham)
 - Discussion and possible motion to approve dates for two candidate forums to be held tentatively on January 26th and February 13th or 16th of this year.
 Copies were distributed of "The Candidate Filing Process" and "Election Timeline."
 Mr. Kirkham explained the events. There was discussion of when to have the second forum.

MOTION (by Mr. Kirkham, seconded by Mr. Starr): The Greater Wilshire Neighborhood Council will hold two candidate forums, one on January 26th at 11:00 a.m. and the second on February 13th at 6:00 p.m. before the scheduled Board Meeting.

CALL for the QUESTION (by Mr. Smith): zero opposed; zero abstained.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

ii. Discussion of planned ad buy with the Larchmont Buzz, to be paid for out of funds previously appropriated for election related expenses at the November 14, 2018 board meeting.

Resident Patty Lombard explained possible advertising of \$300 per month. The Buzz has around 1,300 subscribers; around 40% click every day on their website. Their total social media reaches around 5,000 people, according to Google analytics.

FUNDING MOTION (by Ms. Carroll, seconded by Mr. Winther): The Greater Wilshire Neighborhood Council will allocate up to \$1,275 on advertising with the Larchmont Buzz related to the GWNC election.

DISCUSSION: Mr. Kirkham described other election advertising. This allocation would come from the \$2,500 budget.

FUNDING MOTION PASSED unanimously by a roll call vote of the 18 eligible voters present with all 18 in favor ("Yes" or "Aye") (Appel, Carney, Carpenter, Carroll, D'Atri, Farha, Genewick, Gilman, Gresham, Kirkham, Kumetz, Moser, Rosato, Senigram, Smith, Starr, Winther and Wittmann); zero opposed; zero abstained.

iii. Discussion of 2016 polling place: In planning the 2019 elections, it was discovered that The Barking Lot was not properly compensated for the use of their location for the May 1, 2016 GWNC Elections. It was thought that they had been paid by the City Clerk; however, the City Clerk only covered LAUSD venues. Motion: That the GWNC approve [see the below Motion].

Ms. Carroll explained the above.

FUNDING MOTION (by Ms. Carroll, seconded by Mr. Winther): The Greater Wilshire Neighborhood Council will allocate \$150.00 to compensate The Barking Lot and/or owner Jan Ciganek for the use of their location for the May 1, 2016 GWNC Elections.

DISCUSSION: Ms. Carroll confirmed that this only is for the 2016 election.

FUNDING MOTION PASSED unanimously by a roll call vote of the 18 eligible voters present with all 18 in favor ("Yes" or "Aye") (Appel, Carney, Carpenter, Carroll, D'Atri, Farha, Genewick, Gilman, Gresham, Kirkham, Kumetz, Moser, Rosato, Senigram, Smith, Starr, Winther and Wittmann); zero opposed; zero abstained.

 Ms. Rosato described event outreach and media. They are working with CD4 and nearby organizations to distribute volunteers.

 - A. The Next Environmental & Sustainability Committee Meeting will be on Tuesday, February 12, 2019 at 7:00pm, at Marlborough School, 250 S. Rossmore Ave., Los Angeles, CA 90004
 - i. Featured Speaker: Marilee Kuhlmann, President/CEO, One Water Group, Inc. Ms. Kuhlman, a landscape consultant and sustainable garden designer, will present on "Understanding Drought Tolerant Gardens."
 - Mr. Kirkham noted the above. Ms. Roberts recommended hearing the speaker.
 - B. New Business: Discussion, Planning, and Possible Motion Requesting the Bureau of Street Services and Urban Forestry Division (UFD) to Adopt a 60-Day Notification Period for Proposed Removal of All Street Trees and Adopt an Opt-In Notification System for All Tree Removals Accessible to the Public. Currently, UFD's unofficial policy for tree removal requests is 3 days unless the removal is for 3 or more trees. Request for UFD to adopt a formal 60-Day notification policy.

Copies were distributed of a draft letter from the GWNC to Adel Hagekhalil, Director, L.A. Bureau of Street Services. Mr. Wittman explained the above.

MOTION (by Mr. Wittmann, seconded by Mr. Kirkham): The Greater Wilshire Neighborhood Council will send a letter requesting the Bureau of Street Services and Urban Forestry Division (UFD) to Adopt a 60-Day Notification Period for Proposed Removal of All Street Trees and Adopt an Opt-In Notification System for All Tree Removals Accessible to the Public.

DISCUSSION: Mr. Farha wanted to exclude palm and ficus trees, saying "they ruin the sidewalks -- they're destructive." There was extensive discussion regarding that.

MOTION PASSED by a hand vote; zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Farha).

 - A. 840 N. Orange Drive (Philip Farha) Proposed parkway tree removal. Copies were distributed of an email and photos regarding the site. Mr. Farha recommended opposing the removal.

MOTION (by Mr. Farha, seconded by Mr. Gresham): The Greater Wilshire Neighborhood Council opposes the removal of the tree at 840 N. Orange Dr.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

- B. Restaurant Beverage Ordinance Program: The City Planning Department will be holding a staff-level public hearing on CPC-2018-4660-CA on January 31st at 6:30pm. Written submissions may be sent to esther.ahn@lacity.org.
 - Ms. Moser explained the above. No Motion was made or vote taken.
- C. 545 S. Gramercy Pl (Clayton Przekop) Pursuant to LAMC section 12.27 applicant request a zone variance for a proposed an office use on first floor and residential use at existing two-story building. [note: The GWNC LUC voted unanimously (6/0/0) to support the following motion.] Motion: That the Greater Wilshire Neighborhood Council reiterate its opposition to the project at 545 S. Gramercy Pl. and oppose the appeal.

MOTION (by Ms. Moser, seconded by Mr. Farha): The Greater Wilshire Neighborhood Council reiterates its opposition to the project at 545 S. Gramercy Pl. and opposes the applicant's appeal.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

D. 3477 W. Olympic Blvd (Ariel Gutierrez) CUB to allow the off sale of beer and wine in conjunction with an existing 2739 SF convenience store operating 24 hours daily in a C2-1 zone. ZA-2018-5753-CUB, ENV-2018-5754-CE. In 2014, when originally presented, the applicant stated that they would not ever sell alcohol. The LUC voted 6/0/0 to oppose the CUB. Motion: That the Greater Wilshire Neighborhood Council [see the below Motion].

MOTION (by Ms. Moser, seconded by Mr. Senigram): The Greater Wilshire Neighborhood Council opposes the 7 – Eleven application for a CUB (Conditional Use Beverage) at 3477 W. Olympic Blvd. to allow the off-site sale of beer and wine in conjunction with an existing 2,739 sq. ft. convenience store operating 24 hours daily in a C2-1 zone.

DISCUSSION: Mr. Gresham noted that "they promised they would never, never, ever apply to sell alcohol."

MOTION PASSED by a hand vote with 16 in favor; two opposed; zero abstained.

E. 474 N. Western Ave (Kevin Franklin) A CUB to allow sale/dispensing of beer and wine for onsite consumption in conjunction with an existing 1535 sq. ft. Restaurant w/44 seats and 218 sq. ft. patio w/14 seats. Hours 11 am to 12 am Mon – Wed and 11 am to 1 am Thursday – Sunday in a C2-1 zone. ZA-2018-3156- CUB, ENV-2018-3157-CE. [note: the board previously voted on 12/12/2018 to oppose for last of presentation] Motion: That the Greater Wilshire Neighborhood Council Board oppose the CUB for 474 N. Western Ave.

MOTION (by Ms. Moser, seconded by Mr. Gresham): The Greater Wilshire Neighborhood Council opposes the CUB for 474 N. Western Ave.

DISCUSSION: Mr. Gresham noted that "it impacts our neighborhood."

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

F. 4749 W. Elmwood Ave (Don Tolentino, Brian Cohen) Demolition Application No. 18019-10000-03932 Motion: that the Greater Wilshire Neighborhood Council Board oppose the project, as the Applicant did not appear.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

H. 829 N. Orange Drive: Demolition Pre-inspection Application (Paulo Cova) Application
 No. 18019-20000-05318/B18VN18557 Motion: that the GWNC Board oppose the
 Demolition pre-inspection Application, the applicant did not appear.

MOTION (by Ms. Moser, seconded by Mr. Farha): The Greater Wilshire Neighborhood Council opposes the Demolition pre-inspection Application; the applicant did not appear.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

I. 300 N. Plymouth Blvd: Parking on the 300 block of Plymouth Blvd. has become difficult because of "Mansion Mates". The company sublets rooms and dorm style beds as "Off

Campus Housing" - Living Space (listed on Hot Pads, Trulia and other sites). The operators of the property attended the meeting twice and agreed to reach out to neighbors the original issues were parking and zoning for that type of operation.

Mr. D'Atri reported that the applicant had not appeared at the Larchmont Village Neighborhood Association (LVNA). Ms. Moser explained that the applicant twice appeared at Committee meetings and that they may claim that guests are "family." Mr. D'Atri said "they're attempting to expand a loophole . . . R-1 zoning would become irrelevant." There was extensive discussion of housing policy. No Motion was made or vote taken.
