

Greater Wilshire Neighborhood Council Transportation Committee Meeting May 18, 2020 MINUTES – Approved by the Committee on July 27, 2020

I. WELCOMING REMARKS

A. Call to Order

A duly noticed meeting of the Transportation Committee of the Greater Wilshire Neighborhood Council ("GWNC") was held on Monday, January 13, 2020, via Zoom (online and by telephone). Chairperson Conrad Starr called the meeting to order at 7:01 p.m.

B. Roll Call

Mr. Starr called the roll. Four of the five Committee Members were present at Roll Call: Mr. Starr (Chair), Tucker Carney, Jeffry Carpenter, and Philip Farha. One Committee Member, Jennifer DeVore arrived soon after roll call. *[The GWNC Transportation Committee quorum (the minimum number of Committee Members needing to be present to take binding votes on Agendized Items) was 51% of 5 Committee Seats, or three, so the Committee could take such votes.]*

Also in attendance were eight (8) other non-committee-member attendees and one member of the press.

C. Welcome

Mr. Starr welcomed the assembled group.

II. COMMENTS BY GOVERNMENT REPRESENTATIVES

There were none.

III. GENERAL PUBLIC COMMENT ON NON-AGENDA ITEMS

Mike Riggs asked the Committee's advice for getting a stop sign installed at the intersection of 4th Street and Westminster.

IV. ADMINISTRATIVE ITEMS (Discussion and Possible Action)

A. Review and Adoption of the January 13, 2020 Meeting Minutes

Mr. Farha moved to approve the January 13, 2020 minutes as drafted and presented. Ms. DeVore seconded. The minutes were approved by a vote of 4 yes (Carney, DeVore, Farha, Starr), 0 noes, 1 abstention (Carpenter).

B. Nomination of and Possible Vote on New GWNC Transportation Committee Member(s).

i. Chris Palencia

Mr. Palencia was not present and no nomination was made.

V. OLD BUSINESS

A. GWNC Transportation Committee "Purpose and Procedures"

A draft document was discussed. No motion was made or vote taken.

B. Special Meeting on the Proposed 4th Street Greenway - Date, Meeting Format, Outreach

The above was discussed. No motion was made or vote taken.

VI. <u>NEW BUSINESS</u>

A. Support for Crosswalk on Melrose at Orange

Mr. Farha described the issue. No motion was made or vote taken.

B. Support for Traffic Safety Mitigations at Intersection of Melrose/Highland

Mr. Farha described the issue and said there were no updates. No motion was made or vote taken.

C. Change to Regular Transportation Committee Meeting Date and/or Time

Mr. Starr moved that the Transportation Committee change its standing date to the 4th Monday of odd-numbered months at 7pm. Ms. DeVore seconded. The motion was approved unanimously (Carpenter, Carney, DeVore, Farha, Starr).

D. Support for the Crenshaw Northern Extension Project EIR

Mr. Carpenter moved to recommend that the GWNC send a letter of endorsement for the Metro Rail Crenshaw Line Northern Extension EIR, noting the previous communication from GWNC regarding vertical configuration constraints. Mr. Farha seconded.

There was public comment and committee discussion.

The motion was approved with 4 yeses (Carpenter, Carney, Farha, Starr), 0 noes, and 1 absent (DeVore had stepped away).

E. CIS in support of approved CF Motion #20-0046

This item was not taken up. No motion was made or vote taken.

F. Recommendation of Specific Blocks within the GWNC to nominate for Mayor Garcetti's Slow Streets Program (http://ladot.lacity.org/coronavirus/apply-slow-streetyour-neighborhood)

An informal discussion among committee members and stakeholders was held. No motion was made or vote taken.
