I. WELCOMING REMARKS

A. Call to Order (Caroline Moser)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held online. President Moser called the meeting to order at 7:01 p. m.

B. Roll Call of Board Members and/or Alternates (Conrad Starr).

The Secretary called the roll. Fifteen of the 21 Board Members or their Alternates were present online at the Roll Call: Scott Appel, Hayden Ashworth, Tucker Carney, Jeffry Carpenter, Patricia Carroll (Treasurer), Charles D'Atri, Max Kirkham (Vice President), Bobbie Kumetz, Joy McManus (Alternate for Philip Farha), Caroline Moser (President), Susan Nickels, Cathy Roberts, Owen Smith, Conrad Starr (Secretary) and Joseph Suh. Brian Curran (Alternate for Karen Gilman), Michael Genewick and Jennifer DeVore arrived later. Brian Donahoe, John Gresham and John Winther were absent and not represented by an Alternate. The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) was 13 Members (see the Bylaws at www.empowerla.org/gwnc), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). No Board Seat was vacant. Nine Alternate Seats were vacant [see Item #V. D. 2.; to apply see www.GreaterWilshire.org]. Also attended: approximately 13 Stakeholders and guests.
