1. WELCOMING REMARKS:

A. Call to order

5. <u>NEW BUSINESS</u>

A. Resolution on Automated Litter Bins in High-Density Residential Areas (Joseph Lee Suh) Discussion and Possible Motion calling on LA Sanitation and The City Council to provision and maintain automated litter bins (ALBs) in high-density residential areas for health and hygiene promotion and disease prevention.

Public Comment: GWNC President Caroline Moser noted her reservations about the motion as presented... primarily related to funding and responsibility for refuse removal.

Committee Discussion: Mr. Suh discussed the merits of his proposal... wants to advocate for the entire neighborhood, but program would pilot in Western-Wilton area... Mr. Carney and Ms. Amin expressed their support for the motion, but noted that it was too specific in choosing where proposed litter bins would be placed... Mr. Kirkham asked for clarity from the city as to whether or not the project would be feasible and, if so, how soon it would be possible... Ms. Moser suggested amending the motion to call for a study instead.

Motion: (by Mr. Suh, seconded by Mr. Carney) ...be it resolved, that the Greater Wilshire Neighborhood Council calls on LASAN and the City to immediately provision and maintain ALBs in high-density residential areas throughout Greater Wilshire that opt-in – prioritizing high-density residential areas adjacent to commercial areas – by piloting ALB provision and maintenance in Geographic Area 12 – Western-Wilton in the following six (6) High Priority Placements (i.e., every other corner) between W 3rd St and W 6 th St (North to South), and between S Wilton Pl and S Manhattan Pl (West to East):

RED = High Priority Placement	YELLOW = Priority Placement
