Committee Discussion: Mr. Ashworth informed The Committee that the nonprofit is located in Van Nuys, but reaches all schools within the GWNC... GWNC has been asked to support the event through advertising and mentioning it at our committees... Ms. Amin asked for more info from the organization before a decision is made... Mr. Ashworth offered that it's purpose is to foster STAM learning in LAUSD schools.

Motion: (by Ms. Carroll, seconded by Mr. Suh) that the GWNC Outreach Committee recommend support of Boundless Brilliance in Outreach for LUNAFEST with a focus on how it benefits the GWNC.

 - Council File 20-0963, Neighborhood Council Elections / Fiscal Year 2020-21 / COVID-19 Pandemic

Public Comment: None.

Committee Discussion: The Committee discussed the LA City Council's motion that made all neighborhood council elections vote by mail... Mr. Ashworth asked The Committee if it wanted to submit feedback... The Committee was mixed... supportive of increased access during pandemic, but unsure of how it will be implemented effectively for the first time... Mr. Ashworth shared concerns about special interest categories and how to recruit and register voters for them... Mr. Kirkham noted concern with funding and how the Department of Neighborhood Empowerment could effectively run elections with a reduced budget... Mr. Suh asserted that the GWNC bylaws were written in such a way as to make it difficult to vote... Mr. Kirkham suggested that The Committee focus on how the GWNC will respond to the new election format and complete Outreach around it as well.

Motion: (by Ms. Carroll,) that the GWNC write a CIS in opposition to mail-in voting.

Motion FAILED for lack of a second.
