## 1. WELCOMING REMARKS:

#### A. Call to order

A duly noticed meeting of the Outreach Committee of the Greater Wilshire Neighborhood Council ("GWNC") was held on Saturday, January 2, 2021. In conformity with Governor Newsom's Executive Order N-29-20 (March 17, 2020), and due to concerns over COVID-19, the meeting was conducted entirely telephonically and over Zoom. GWNC Vice President Max Kirkham called the meeting to order at 9:36am.

The GWNC Outreach Committee quorum (the minimum number of Committee Members needing to be present to take binding votes on agendized items) is 51% of the seven filled Committee Seats, or 4 members.

### 2. GENERAL PUBLIC COMMENT ON NON-AGENDA ITEMS

Thao Tran from the Wilshire Community Police Advisory Board (CPAB) joined the committee to announce and discuss the creation of the Procedural Justice and Equity Committee and invite members of the Committee to join...

Committee member Colette Amin arrived at 9:40am

Ms. Tran noted that the committee would also include 4 officers from Wilshire Division... she asked if the GWNC would share information about the new Committee and CPABs renewed focus on developing and elevating possible solutions to issues in policing in the community... anyone can join, not just stakeholders within Wilshire Division... Mr. Kirkham requested a more regular line of communication when times get difficult or the community is protesting, noting that the GWNC went

month's without LAPD outreach... Mr. Suh shared that the GWNC Board adopted the resolution "Condemning All Acts of Police Brutality, Racial Profiling, and Excessive Force and Promoting Trust and Accountability Between Law Enforcement and Communities They are Sworn to Serve (https://drive.google.com/file/d/1Y31Ey9mqikIYamJ3flgtO4s2pWtuZE4j/view?usp=sharing)" this past June, 2020, and expressed concern regarding officer use of rubber bullets, projectiles, and excessive force at recent protests, including those occurring outside the Getty House and over the summer, and echoed Mr. Kirkham's call for robust reengagement and dialogue with communities.

Caroline Moser (GWNC Board President) noted that she received an email from a stakeholder requesting more information about getting involved in the GWNC area... she suggested that Outreach compile a list of available volunteer organizations operating within the GWNC.

### 4. OLD BUSINESS

#### A. COVID-19/Novel Coronavirus

Discussion and Review of GWNC Response to the ongoing pandemic

Public Comment: None.

Committee Discussion: Mr. Suh referred to his motion in agenda item V.B... Ms. Amin suggested working with Congressman Santiago's office to bring COVID testing to the GWNC...

Mr. Suh suggested a program to help highlight small businesses within the GWNC... Committee discussed Department of Neighborhood Empowerment (DONE) restrictions on promoting businesses and ways a possible program might move forward within those restrictions.

Action: No motions made or action taken.

#### B. Citizen Recognition Program

Public Comment: None.

Committee Discussion: Committee discussed the possibility of awarding Citizen Recognition awards to non-individuals... Mr. Kirkham referred to previous discussions in which the Committee decided not to open qualifications to non-individuals... Mr. Suh asserted that the language of the award as currently written allows for it... suggested allocating funding to purchase lawn signs and bumper stickers for those awarded.

Action: No motions made or action taken.

C. Town Hall Series (Civics 101, Budget 101, et al.) (Julia Moser) Discussion and possible motions to develop a series of town halls focused on educating the Greater Wilshire community on budget and legislative processes in the city of Los Angeles.

Public Comment: None.

Committee Discussion: Ms. Moser reminded the Committee that County 101 would be on January 11 at 7:00pm... asked committee members to help promote... is already thinking about the next one... will come to the next meeting with ideas.

Action: No motions made or action taken.

## D. 2021 Neighborhood Council Elections

Discussion and possible action on outreach strategies for the 2021 Neighborhood Council Election.

Public Comment: None.

Committee Discussion: Mr. Suh questioned the GWNC's requirement for documentation for voter verification, instead of attestation... argued attestation would help increase turnout by reducing the requirement... Mr. Carney agreed... Committee noted that stakeholder verification requirements were established by City Council action and by the City Clerk election handbook... City Clerk will work with Stakeholders experiencing difficulty with verification.

Action: No motions made or action taken.

## 5. <u>NEW BUSINESS</u>

A. Committee Agenda Design Review

Discussion and possible action on current agenda layout and design.

Public Comment: None.

Committee Discussion: Brief discussion on member's ideas to improve agenda legibility... Mr. Suh agreed to work on possible solutions in his role as Vice Chair.

Action: No motions made or action taken.

B. Recommendation of Emergency Funding Allocation (Joe Suh)

Public Comment: None.

Committee Discussion: Mr. Suh stressed that too large a portion of the GWNC annual budget is spent on administrative costs... would like to see more funding go into the community... identified four Title I elementary schools within the GWNC that require funding assistance... The Committee discussed the limiting factors on the Board that necessitate payment of staff to assist in Board operations... Mr. Kirkham reminded the Committee that the GWNC had previously awarded over \$2500 in emergency funding and \$1000 in Neighborhood Purpose Grants to local organizations since the start of the pandemic... furthermore, per neighborhood council funding guidelines, motions for emergency funding need to specify exactly what funding is being allocated to and so the proposed motion would most likely not be approved by the City Clerk for fund dispersal... Ms. Carroll reminded the Committee that the City Council had recently reduced the GWNC's budget by \$10,000.

MOTION (by Mr. Suh) In recognition of the extraordinary and ongoing efforts of Greater Wilshire students, parents, educators, and stakeholders to help ensure learning continues in the face of unprecedented challenges, the Greater Wilshire Neighborhood Council shall allocate from its FY 2019/2020 rollover funds account a grant in the amount of \$500 to each of the following Los Angeles Unified School District (LAUSD) designated by the State of California and the U.S. Government as Title I, Part A, elementary schools serving predominantly children from low-income families within the Greater Wilshire Neighborhood Council's jurisdiction—Van Ness Avenue Elementary School; Wilshire Crest Elementary School; Wilshire Park Elementary School; and Wilton Place Elementary School—for essential activities consistent with the latest Emergency Order from the City of Los Angeles, including for purposes of:

- Facilitating distance learning and Grab & Go Food Centers;
- procuring personal protective equipment including masks, face shields, plexiglass
  or similar transparent barriers, and cleaning and sanitation supplies and equipment,
  including soap, cleansers, hand sanitizers, and disinfectants for when in-person
  learning is lawful and appropriate;
- promoting flu and COVID-19 vaccination;
- planning for the upcoming school year;
- or performing other essential functions provided that adherence to public health recommendations, including wearing masks, where age-appropriate, and distancing of at least six-feet per person, is maintained.

**MOTION FAILED** for lack of a second.

## C. Discussion on Budget Transparency

Discussion on details of GWNC Budget and ways the Committee can improve community insight into expenditures and standing allocations as approved by board action, including funding available to each committee.

Public Comment: None.

Committee Discussion: Mr. Suh requested that the GWNC Budget be more prominently displayed on the GWNC website and that committees receive more regular updates on funding available to them... Mr. Kirkham agreed that more information on available funding would help committees be more effective overtime.

Action: No motions made or action taken.

Committee Member Tucker Carney left the meeting at 12:16pm.
