

Greater Wilshire Neighborhood Council Environmental & Sustainability Committee Meeting Minutes, Tuesday, December 1, 2020 Approved February 2, 2021

1. Call to Order and Roll Call (Dan Kegel)

A duly noticed meeting of the Greater Wilshire Neighborhood Council ("GWNC") Sustainability Committee was held on Tuesday, December 1, 2012, via Zoom. Chairperson Dan Kegel called the meeting to order at 7:10 p.m.
