

Greater Wilshire Neighborhood Council Resilience Committee Regular Meeting June 2, 2021 MINUTES – Approved by the Committee on July 8, 2021

# I. WELCOMING REMARKS

### A. Call to Order

A duly noticed meeting of the Resilience Committee of the Greater Wilshire Neighborhood Council ("GWNC") was held on June 2, 2021, via Zoom, Webinar ID 889 6831 9278.

Conrad Starr (Acting Chair) called the meeting to order shortly after 7:00 p.m.

Mr. Carpenter moved to recommend that the GWNC select Hayden Ashworth, Jeffry Carpenter, April Hannon, Max Kirkham, and Conrad Starr as members of the Resilience Committee. Ms. Hannon seconded. The motion carried with three voting yes (Carpenter, Hannon, Starr). Mr. Ashworth was ineligible.
