

Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, July 14, 2021 Approved September 8, 2021

In conformity with the Governor's Executive Order N-29-20 (March 17, 2020) and due to concerns over COVID-19, this duly noticed meeting was held entirely online and telephonically.

I. WELCOMING REMARKS

A. Call to Order (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held online. President Conrad Starr called the meeting to order at 6:33 p. m

B. Roll Call (Jennifer DeVore)

The Secretary called the roll. Fifteen of the 21 Board Members or their Alternates were present online at the Roll Call: Jeffry Carpenter, Cindy Chvatal-Keane, Brian Curran, Charles D'Atri (Vice-President), Jennifer DeVore (Secretary), Mike Genewick, Gary Gilbert, John Gresham (Alternate for Michael Duggan), Stephanie Lee, Beau Lloyd (Alternate for Stephanie Shim), Cathy Roberts, Owen Smith, Conrad Starr (President), Bindhu Varghese and John Winther. Five Board Members arrived later: Scott Appel, Hayden Conner Ashworth (Alternate for Bailey Benningfield), Patricia Carroll (Treasurer), Philip Farha (Alternate for Christopher Hauck) and Juan Portillo Jr. Brian Donahoe was absent and not represented by an Alternate. The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) was 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-board-rules), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). No Board Seat was vacant. Five Alternate Seats were vacant [see Item #VII. B. 2; to apply see www.GreaterWilshire.org]. Also attended: at least 17 Stakeholders and guests, including Parliamentarian James Stewart.

Joy McManus reported that LAHSA [LA Homeless Services Authority; 213-683-3333; http://lahsa.org; www.facebook.com/lahsa.org] has 250 people doing outreach, and that the City is required to build 456,000 housing units in the next eight years. She described funding available to buy housing and provide legal services. The City, on July 27th, will consider legislation regarding sleeping or tenting on sidewalks.

Larchmont Blvd.: (Dafne Gokcen) Conditional Use Permit to allow the sale and dispensing of a full line of alcoholic beverages in conjunction with a 1,874 sq ft restaurant with 38 interior seats and 12 seats on a 163 sq ft patio partially located on the public right-of-way, with hours of operation from 8:00 am - 12:00 am daily. Case No. ZA-2021-4313-CUB. Zoning [Q]C2-1D. Motion: That the Greater Wilshire Neighborhood Council oppose the CUP for the restaurant located at 242-244 N. Larchmont Blvd. as presented June 22, 2021 for a full line of alcohol and closing hours of midnight.

This Agenda Item was addressed after Item #X. B. 4.

MOTION (by Mr. Gresham, seconded by Ms. DeVore): The Greater Wilshire Neighborhood Council opposes the CUP for the restaurant located at 242-244 N. Larchmont Blvd. as presented at the June 22, 2021 Land Use Committee meeting for a full line of alcohol and closing hours of midnight, which the Committee decided was inappropriate for Larchmont Village restaurants.

DISCUSSION: There was discussion of this. Project representative Manny Diaz said they want to "narrow" their requests; "we have every intention" to "alter" their request to accommodate community requests. They want to make "one more presentation to the Land Use Committee." There was discussion about whether to vote on this at this time.

MOTION to POSTPONE (by Ms. Roberts, seconded by Mr. Farha): The Greater Wilshire Neighborhood Council Postpones Item #X. B. 2. to the next Board Meeting.

DISCUSSION: Mr. Gresham noted that this main Motion is typical for the Committee; the developer can re-present. Ms. Usher believed it to be "wrong" for a developer to have project discussions with Committee and/or Board Members outside of public meetings. Mr. Winther said "we only can deal with the printed word." Ms. Varghese believed it to be "reasonable" to postpone such a vote "on a case-by-case basis."

MOTION to POSTPONE FAILED by a roll call vote of the 18 eligible voters present with four in favor ("Yes" or "Aye") (Gilbert, Farha, Roberts and Varghese); 10 opposed ("No" or "Nay") (Appel, Carroll, Chvatal, Curran, D'Atri, DeVore, Genewick, Gresham, Smith and Winther); four abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Ashworth, Carpenter, Lloyd and Starr).

DISCUSSION: Mr. Gresham reiterated that this is a "standard" Motion for the GWNC.

MAIN MOTION PASSED by a roll call vote of the 18 eligible voters present with 13 in favor ("Yes" or "Aye") (Appel, Ashworth, Carpenter, Carroll, Chvatal, Curran, D'Atri, DeVore, Farha, Genewick, Gresham, Smith and Winther); zero opposed; five abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Gilbert, Lloyd, Roberts, Starr and Varghese).
