

Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, November 10, 2021 Minutes Approved December 8, 2021

In conformity with the Governor's Executive Order N-29-20 (March 17, 2020) and due to concerns over COVID-19, this duly noticed meeting was held entirely online and telephonically.

I. WELCOMING REMARKS

A. Call to Order (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held online. President Conrad Starr called the meeting to order at 6:31 p. m. He reminded that there will be opportunities for public comment during Agenda Items and during the "Public Comment" Item. He reminded that Board Members who need to recuse from an Item need to do so before the Item starts being considered.

B. Roll Call (Jennifer DeVore)

The Secretary called the roll. Seventeen of the 21 Board Members or their Alternates were present online at the Roll Call: Scott Appel, Hayden Conner Ashworth, Jeffry Carpenter, Patricia Carroll (Treasurer) (arrived at 6:34), Cindy Chvatal-Keane, Joe Suh (Alternate for Brian Curran), Charles D'Atri (Vice-President), Jennifer DeVore (Secretary), Brian Donahoe, John Gresham, Mike Genewick, Gary Gilbert, Cathy Roberts, Owen Smith, Conrad Starr (President), Bindhu Varghese and John Winther. Juan Portillo Jr. and Stephanie Shim arrived later. Christopher Hauck and Stephanie Lee were absent and not represented by an Alternate. The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) was 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-board-rules), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). No Board Seat was vacant. Six Alternate Seats were vacant [see Item #V. D. 2.; to apply see www.GreaterWilshire.org]. Also attended: approximately 12 Stakeholders and guests.

Mr. Gilbert noted the above and that there is at least one Committee Seat available.

Ave.; they asked Metro to bring more data.

XIII. <u>NEW BUSINESS</u> (Discussion and Possible Action)

A. Homeless Count (Christopher Hauck - Homelessness Liaison). The count, run by the LA Homeless Services Authority (LAHSA), will be held on January 27, 2022. 1. Proposed Motion: that the GWNC Board opt-in as a site coordinator sponsor/agency for the 2022 Annual Homeless Count with board member Christopher Hauck and stakeholder Max Kirkham designated as the site coordinators.

MOTION (by Ms. DeVore, seconded by Ms. Roberts): The Greater Wilshire Neighborhood Council will participate in the 2022 point-in-time Homeless Count on 1/27/22 at a deployment center TBD; the Greater Wilshire Homeless Count will be done in partnership with the Los Angeles Homeless Services Authority (LAHSA); furthermore, the GWNC designates board member Christopher Hauck and stakeholder Max Kirkham as its site coordinators and liaisons to LAHSA for this effort.

MOTION PASSED unanimously by consent; zero opposed; zero abstained.

2. Proposed Motion: That the GWNC Board approve up to \$300.00 for rental fees for a coordination site. Note: in the past, we have used the Social Hall at Hope Lutheran Church for \$200-\$250 and this may be available.

FUNDING MOTION (by Mr. D'Atri, seconded by Ms. Chvatal): The Greater Wilshire Neighborhood Council approves up to \$300.00 for rental fees for a coordination site.

DISCUSSION: Mr. Starr explained that this is for the Homeless Count.

FUNDING MOTION PASSED by a roll call vote of the 18 eligible voters present with 17 in favor ("Yes" or "Aye") (Appel, Ashworth, Carpenter, Carroll, Chvatal, Curran, D'Atri, DeVore, Donahoe, Gilbert, Gresham, Portillo, Roberts, Shim, Smith, Varghese and Winther); zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Starr). Mr. Genewick was ineligible to vote due to not having current Ethics Training and/or Funding Training and/or not having signed the Code of Conduct.

3. Proposed Motion: That the GWNC Board approve up to \$150 for purchasing refreshments and PPE for Homeless Count volunteers.

FUNDING MOTION (by Ms. Chvatal, seconded by Mr. Smith): The Greater Wilshire Neighborhood Council approves up to \$150 for purchasing refreshments and Personal Protective

Equipment for Homeless Count volunteers.

FUNDING MOTION PASSED by a roll call vote of the 18 eligible voters present with 17 in favor ("Yes" or "Aye") (Appel, Ashworth, Carpenter, Carroll, Chvatal, Curran, D'Atri, DeVore, Donahoe, Gilbert, Gresham, Portillo, Roberts, Shim, Smith, Varghese and Winther); zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Starr). Mr. Genewick was ineligible to vote due to not having current Ethics Training and/or Funding Training and/or not having signed the Code of Conduct.

XIV. <u>COMMUNITY IMPACT STATEMENTS (CIS)</u>, <u>PROCLAMATIONS</u> (Discussion and Possible Action)

A. LA City Council Redistricting [This Item was addressed after Item #IV.] 1. Possible Motion: to submit Community Impact Statements and/or letters regarding the Los Angeles City Council Redistricting and the Report, Motions, and/or

Recommendations of the Ad Hoc Redistricting Commission.

MOTION (by Mr. Gresham, seconded by Mr. Carpenter): The Greater Wilshire Neighborhood Council will submit a CIS statement on City of Los Angeles redistricting that expresses its opposition to the Ad Hoc Redistricting Commission's map of Friday, November 5, 2021, which divides the GWNC between CD 5 and CD 13, and that asks the City Council to unite the Greater Wilshire Neighborhood Council in CD5, as is consistent with the City Charter's governing principles for redistricting.

DISCUSSION: Mr. Gresham explained that "we needed to restate our position."

Board Member Bindhu Varghese was unavailable to vote at this time (7:01), making 17 Board Members present online (the GWNC Board quorum was thirteen).

Mr. Starr further explained that "we want to be united in one Council District."

Board Member Stephanie Shim arrived at this time (7:06), making 18 Board Members present online (the GWNC Board quorum was thirteen). She indicated that there were Internet connectivity access problems.

Sheri Gasche, of the South Hollywood Neighborhood Association, reported that they've many times requested to be only in CD5. Mr. Gresham noted that "we've stated all along we want to be in one Council District . . . Five."

MOTION PASSED by a roll call vote of the 18 eligible voters present with 11 in favor ("Yes" or "Aye") (Appel, Ashworth, Carpenter, Carroll, Curran, D'Atri, Genewick, Gresham, Roberts, Smith and Winther); zero opposed; seven abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Chvatal, DeVore, Donahoe, Gilbert, Portillo, Shim and Starr).

B. CF 20-1536 - STAP - Sidewalk Transit Amenities Program (CIS due by 5pm Nov 12) (Roberts)

Ms. Roberts noted that former Board Member Karen Gilman requested that the Board consider this. Ms. Roberts explained the Program. Mr. D'Atri noted that the Quality of Life Committee discussed this; there was no consensus. No Motion was made or vote taken.

The next Agenda Item addressed was Item #V.

XV. BOARD MEMBER COMMENTS/ANNOUNCEMENTS

Mr. Portillo commented that he and Mr. Curran will outreach November 14th at the Farmer's Market regarding Neighborhood Purposes Grant availability and the November 17th Town Hall. Ms. Chvatal was concerned about community Members who represent themselves as being Board Members; one Stakeholder communicated to CD5 that the GWNC wanted to be split between two City Council Districts, which it never requested. Mr. D'Atri announced that the Quality of Life Committee will meet Wednesday, November 24th at 5:00 p.m.; he encouraged feedback.
