#### I. WELCOMING REMARKS:

#### A. Call to order

A duly noticed meeting of the Outreach Committee of the Greater Wilshire Neighborhood Council ("GWNC") was held on Tuesday, March 16th, 2022). In conformity with Governor Newsom's Executive Order N-29-20 (March 17, 2020), and due to concerns over COVID-19, the meeting was conducted entirely telephonically and over Zoom. Outreach Chair Colette Amin called the meeting to order at 18:30pm.

The GWNC Outreach Committee quorum (the minimum number of Committee Members needing to be present to take binding votes on agendized items) is 51% or more of the 8 filled Committee Seats, or 5 members.

### II. GENERAL PUBLIC COMMENT ON NON-AGENDA ITEMS

A. GWNC Board Member Cindy Chvatal Keane joined the meeting to comment that the agendized PLAY Program was an LADOT program and thus the purview of the Transportation Committee. Cindy also questioned the role and reasoning behind the Outreach Liaison positions and whether they were allowed under Board rules.

Discussion; Brian Curran gave a brief history of the liaison positions. Chair Colette Amin replied that the liaisons positions were requested by GWNC President Conrad Star and that the Outreach Committee is well within its rights to discuss and research any issue.

Cindy suggested that the liaison issue and the PLAY Program be brought to the Board for discussion.

Discussion among the committee about what the parameters we have to set our own agenda. New Board rules have been drafted, but yet to be reviewed by the committee.
