

Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, November 9, 2022 Approved December 2022

In conformity with the Governor's Executive Order N-29-20 (March 17, 2020) and due to concerns over COVID-19, this duly noticed meeting was held entirely online and telephonically.

I. WELCOMING REMARKS

A. Call to Order (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held online. President Conrad Starr called the meeting to order at 6:30 p. m. and explained procedures.

B. Roll Call (Jennifer DeVore)

The Secretary called the roll. Twelve of the 20 Board Members or their Alternate(s) were present online at the Roll Call, which is not a quorum: Scott Appel, Tommy Atlee (Alternate for Hayden Conner Ashworth), Raphie Cantor, Jeffry Carpenter, Patricia Carroll (Treasurer), Brian Curran, Charles D'Atri (Vice-President), Jennifer DeVore (Secretary), Gary Gilbert, Cathy Roberts, Conrad Starr (President) and John Winther. Cindy Chvatal-Keane, John Gresham and Owen Smith arrived later. Stephanie Lee, Beau Lloyd and Benny Rosenberg were absent and not represented by an Alternate. The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-boardrules), so at this time the Board could only take public comments, could not have any official discussions, and could not make any Motions or take any votes. Eighteen of the 21 Board Seats were filled (by election or appointment). Three Board Seats were vacant [Area 3 – Country Club Heights, Area 9 – Oakwood-Maplewood-St. Andrews and Area 12 - Western-Wilton; see Item #VII. D. 1; to apply see www.GreaterWilshire.org]. Seven Alternate Seats were vacant [see Item #VII. D. 2; to apply see www.GreaterWilshire.org]. Also attended: at least 12 Stakeholders and guests.

A. CA Senator Anthony Portantino, 25th District (SPECIAL GUEST). Senator Portantino, who represents areas east of Greater Wilshire, will discuss and answer questions about

recent state legislation regarding campus safety (SB 906), school funding (SB 830), active transportation (SB 932), and land use and parking requirements (AB 2097).

Senator Portantino spoke about State education funding.
