

# Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, July 12, 2023 Approved August 9, 2023

### I. WELCOMING REMARKS

A. Call to Order (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles, CA 90005. President Conrad Starr called the meeting to order at 6:39 p. m. and explained procedures.

- C. Seating and Roll Call of New Board Members.

The Secretary called the roll. All 20 of the 20 Board Members or their Alternate(s) were present at the Roll Call: Mark Alpers (Alternate for Brian Curran), MJ Anderson (Alternate for Tommy Atlee), Scott Appel, Selene Betancourt, Jeffry Carpenter, Patti Carroll, Cindy Chvatal-Keane, Romi Cortier, Charles D'Atri, Jennifer DeVore, John Gresham, Jesseca Harvey, Julie Kim, Mark McQueen, David Meister (Alternate for Gary Gilbert), Alex Nava, Benjamin Rosenberg, Sixto Sicilia, Owen Smith and Conrad Starr. Brian Curran arrived later. John Winther and Tess Paige had resigned. No Board Member was absent. The GWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-board-rules), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). One Board Seat was vacant. Seven Alternate Seats were vacant [see Item #II. A. 3; to apply see www.GreaterWilshire.org]. Also attended: approximately 18 Stakeholders and guests.

Mr. Nava was Seated at this time, keeping 20 Board Members (or their Alternate(s)) present (the GWNC quorum at this Meeting was thirteen).

**MOTION** (by Mr. Gresham, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council appoints Andy Galan as its Area 12 - Western-Wilton representative.

Board Member Brian Curran had arrived by this time, replacing his Alternate Mark Alpers, keeping 20 Board Members present (the GWNC Board quorum is thirteen).

**MOTION PASSED** unanimously by a roll call vote of the 20 eligible voters present with all 20 in favor ("Yes" or "Aye") (Anderson, Betancourt, Carpenter, Carroll, Chvatal-Keane, Cortier, Curran, D'Atri, DeVore, Gresham, Harvey, Kim, McQueen, Meister, Nava, Rosenberg, Sicilia, Smith and Starr); zero opposed; zero abstained.

Mr. Galan was Seated at this time, making 21 Board Members (or their Alternate(s)) present (the GWNC quorum at this Meeting was thirteen).

John Darnell, a Neighborhood Empowerment Advocate of the L.A. Dept. of Neighborhood Empowerment (DONE) [213-978-1551; www.EmpowerLA.org], noted that new Board Members have a 30-day "grace period" during which, before they complete their trainings, they can vote on non-funding Motions.

b) Area 1 (Brookside) Alternate: Julie Stromberg

**MOTION** (by Ms. DeVore, seconded by Ms. Chvatal): The Greater Wilshire Neighborhood Council ELECTS Julie Stromberg as the Area 1 (Brookside) Alternate Representative [Alternate] Board Member.

**MOTION PASSED** unanimously by a hand vote of the 21 eligible voters present with all 21 in favor; zero opposed; zero abstained.

c) Area 6 (La Brea Hancock) Alternate: Cathy Roberts

Mr. Sicilia nominated Ms. Roberts. There were no other nominations.

**MOTION** (by Mr. Sicilia, seconded by Ms. DeVore): The Greater Wilshire Neighborhood Council ELECTS Cathy Roberts as the Area 6 (La Brea Hancock) Alternate Representative [Alternate] Board Member.

**MOTION PASSED** unanimously by a hand vote of the 21 eligible voters present with all 21 in favor; zero opposed; zero abstained.

d) Area 10 (Ridgewood-Wilton-St Andrews Square) Alternate: Bob Reeves

Ms. DeVore nominated Mr. Reeves. There were no other nominations.

**MOTION** (by Ms. DeVore, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council ELECTS Bob Reeves as the Area 10 (Ridgewood-Wilton-St Andrews Square) Alternate Representative [Alternate] Board Member.

**MOTION PASSED** unanimously by a hand vote of the 21 eligible voters present with all 21 in favor; zero opposed; zero abstained.

e) Education Alternate: Kelly Rielly

Mr. D'Atri nominated Ms. Rielly. There were no other nominations.

**MOTION** (by Mr. D'Atri, seconded by Ms. DeVore): The Greater Wilshire Neighborhood Council ELECTS Kelly Rielly as the Education Alternate Representative [Alternate] Board Member.

Board Member Brian Curran had/arrived at/by this time (7:05), replacing his Alternate Mark Alpers, keeping the number of Board Members (or their Alternate(s)) present at 21 (the GWNC Board quorum is thirteen).

**MOTION PASSED** unanimously by a hand vote of the 21 eligible voters present with all 21 in favor; zero opposed; zero abstained.

    - o Each Nominee must accept or decline the nomination.
    - Nominees may speak for up to 5 minutes.
    - Voting shall be by roll call.
    - Per Article VI, Section 3 of the Bylaws, "All Officers shall be elected from among members of the Board by a Board majority vote..." If no candidate receives a majority, a runoff vote will be held between the two candidates who received the greatest number of votes.
  - 2. Nominations, Discussion, and Election of President of the Greater Wilshire Neighborhood Council (GWNC Bylaws Article VI. Section 2.A.).

**MOTION** (by Mr. D'Atri, seconded by Mr. Gresham): The Greater Wilshire Neighborhood Council ELECTS Conrad Starr as President of the Greater Wilshire Neighborhood Council.

Five (Anderson, Cortier, Kim, Nava and Sicilia) were ineligible to vote due to not having

VIII. <u>LAND USE COMMITTEE</u> (Discussion and Possible Action) (Acting Chair: Brian Curran)

[The following sub-section first paragraphs are copied from the Agenda.]

- A. Report on the June 27, 2023 Land Use Committee Meeting Recommendation of Land Use Committee Leadership and Membership for Board Action in July: With the retiring of two current Committee Members, David Trainer of Area Five and Tommy Atlee of Area 14, the total number of Committee Members is reduced to nine, and will be put forward as the Land Use Committee, with Brian Curran as the Chair.
  - Mr. Curran explained the Committee's role.
- B. Proposed Motion: The GWNC [see the below Motion].

MOTION (by Mr. Curran, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council selects Patricia Carroll (Area 10), Rory Cunningham (Area 10), Brian Curran (Area 14), Karen Gilman (Area 7), John Gresham (Area 13), Dick Herman (Area 10), Susan O'Connell (Area 10), Daniela Prowizor-Lacayo (Area 1), and Jane Usher (Area 14) as members of the Land Use Committee, with Mr. Curran to serve as Committee Chair.

**DISCUSSION**: There was discussion about the Committee's composition. Mr. Gresham urged to keep Members who are architects. Ms. Carroll noted the uniqueness of GWNC communities. Mr. Starr noted the need to adhere to the Brown Act. Board Alternate MJ Anderson noted the importance of "diversity of perspective." It was agreed that Mr. Curran would continue as Chair but not to vote on the other Members, pending further work by the Committee.
