I. WELCOMING REMARKS

A. Call to Order (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles, CA 90005. President Conrad Starr called the meeting to order at 6:31 p. m. and explained procedures.

Tommy Atlee, Andy Galan, Julie Kim and Patricia Carroll (Treasurer) arrived later. Two Board Members were absent and not represented by an Alternate: Benny Rosenberg and Sixto Sicilia. Stephanie Lee, Beau Lloyd and John Winther no longer were Board Members. The GWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-board-rules), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). No Board Seat was vacant. Eight Alternate Seats were vacant [see Item #V. A. 2.; to apply see www.GreaterWilshire.org]. Also attended: approximately 25 Stakeholders and guests.

Board Members Patti Carroll and Tommy Atlee arrived at this time (6:35), making 17 Board Members (or their Alternate(s)) present (the GWNC quorum was thirteen.)

Pelayo encouraged that, if you see someone suspicious, such as "walking up and down
driveways . . . sitting in a car" for a long time, call 9-1-1 and say "because we've had
residential burglaries, we've been advised by the LAPD" to call.

D. LADWP (Michael Ventre - michael.ventre@ladwp.com). Explanation: Michael Ventre, Senior Public Relations Specialist at LADWP, will provide a brief overview of DWP's upcoming maintenance project on Murfield and 3rd St. Construction is estimated to run from late September to late January. DWP will take the necessary precautions to minimize disruptions for residents in the area and comply with the HPOZ.

Mr. Ventre presented and introduced their team. He explained service interruptions. The Project Engineer described both project phases. He said that, for phase one on Muirfield between 3rd and 6th, "mail delivery and trash pickup are not going to be affected." Phase two on 3rd Street is planned to last three to four weeks and will have "no impact to parking." Both phases' work will be Monday-Friday 8:00 a.m.-6:00 p.m. and occasional

Saturdays 8:00 a.m.-6;00 p.m. They're digging 10-12 feet down. Water will be turned off for up to eight hours at a time. Sidewalks "are going to be accessible all the time." Staff said "we are using steel for this particular station . . . the existing pipe is cast iron." They will outreach to schools about the project.

- VIII. <u>LAND USE COMMITTEE</u> (Discussion and Possible Action) (Acting Chair: Brian Curran).
 - A. Report on the July 25, 2023 Land Use Committee Meeting. There was no report.
 - B. 3377 W. Olympic Blvd: Pursuant to LA Municipal Code Section 12.37 1.3, a waiver of required dedication and improvements has been requested to provide relief from the requirement to: Complete the dedication process of 3' along St. Andrews Pl. and 5' along Olympic Blvd. Case no: DIR-2022-2825-TOC-SPR-WDI-HCA. Motion: The GWNC [see the below Motion].

Mr. Gresham explained the above.

MOTION (by Mr. Gresham, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council supports a waiver of required dedication and improvements, pursuant to LA Municipal Code Section 12.37 1.3, to provide relief from the requirement to: Complete the dedication process of 3' along St. Andrews Pl. and 5' along Olympic Blvd. for the proposed project at 3377 W. Olympic Blvd., with the Council's support subject to the submittal and city approval of a landscape, irrigation, and maintenance plan to be funded in perpetuity by the developer and its successors for the area where the dedication will be waived.

Board Member Cindy Chvatal stepped away at this time (8:32), making 18 Board Members (or their Alternate(s)) present (the GWNC quorum was thirteen).

MOTION PASSED by a hand vote of the 18 eligible voters present with 14 in favor (Alpers, Appel, Atlee, Betancourt, Carpenter, Carroll, Cortier, D'Atri, Gresham, Harvey, McQueen, Nava, Smith and Trainer); zero opposed; four abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Galan, Kim, Meister and Starr).

C. 300 N. Plymouth Blvd: Nuisance Party House Motion: The GWNC requests [see the below Motion].

Mr. Gresham reported that "many, many neighbors" attended the Committee meeting. He described the party house problems.

MOTION (by Mr. Gresham, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council requests that Council District 13, LAPD Olympic Division, the LA Department of City Planning, the LA Department of Building and Safety, the LA City Attorney's Office, FilmLA, and all other applicable City or state agencies actively support the North Plymouth Blvd. Coalition in their efforts to restore a safe and secure environment in the area of Larchmont and Windsor Square, principally bounded by Rosewood Avenue to the North, Beachwood Drive to the East, Windsor Blvd. to the West, and First Street to the South, by ending the use of 300 N. Plymouth as a Party and Event venue.

DISCUSSION: Resident Sam Uretsky explained the Neighborhood Prosecutor Program and said "the Neighborhood Prosecutor played a key and vital role . . . encouraging . . . [to] cite offenses . . . [There's] a lack of transfer information." Delilah Loud, head of the North Plymouth Association, which has more than 40 Members, appreciated TWNC support. Resident Dorie Lobel said "there's been a lot of intimidation coming out of that house . . . three times a week . . . it's converted into a nightclub." He described security guards' and partygoers' intimidating behavior. One "absolutely drunk, threw up on the street . . . There's been so many parties it's hard to keep track." He described vandalism to his home and added "there's also a lot of racing on the street." Resident Robin Park said that, for "two years . . . illicit use of drugs, underage drinking . . . illegal activities . . . It's a family neighborhood . . . It's making the environment unsafe . . . The noise is out of control . . . from three in the afternoon to one on the morning . . . drag racing . . . littering . . . defecating." Resident Knox White reported that a Police Officer said "weren't you 17 once? . . . [There's been] obscene graffiti . . . [They] charge 40 bucks at the door . . . The girls are getting waved in . . . This is . . . a money-making enterprise . . . a commercial enterprise." Resident Tracy Clark said "there's a cluster of traffic . . . Cars revving up . . . Why isn't [the Party House Ordinance] being enforced? . . . It's disruptive to the neighbors . . . It's against our zoning laws." Senior Lead Officer Pelayo reported that "emails, photos, videos" have been sent to him. "Obviously, it's a nuisance to the community" and "nuisance abatement" is needed. However, all Permits were secured, including alcohol sales.

CD13's Ms. Martinez said it's "on [her] radar . . . We're in the process of awaiting an investigation from the Dept. of Building and Safety." The alcohol Permit is allowed for holding events. CD13 is working to determine how the Permits were granted. Mr. D'Atri reported "unpermitted film shoots . . . This is an outrageous situation." Ms. Carroll said "they're obviously selling tickets." Officer Pelayo said the Neighborhood Prosecutor was unavailable due to City Attorney directive. He reported that he asked

how "they've been able to get a Permit every single night?" Mr. Gresham noted "if they're running a business, they should be paying taxes." Mr. Uretsky said "there're numerous violations in plain sight that Officers driving by have seen." Mr. D'Atri said "we're asking for Councilmember Soto-Martinez to talk directly with the City Attorney."

Board Member Cindy Chvatal had returned by this time, making 19 Board Members present (the GWNC Board quorum was thirteen.

MOTION PASSED unanimously by a roll call vote of the 19 eligible voters present with all 19 in favor ("Yes" or "Aye") (Alpers, Appel, Atlee, Betancourt, Carpenter, Carroll, Chvatal, Cortier, D'Atri, Galan, Gresham, Harvey, Kim, McQueen, Meister, Nava, Smith, Starr and Trainer); zero opposed; zero abstained.

The next Agenda Item addressed was Item #III. C.

D. Committee Membership: With the resignation of three current Committee Members, David Trainer (Area 5), Tommy Atlee (Area 14), and Susan O'Connell (Area 10), the total number of Committee Members is reduced to eight, leaving one seat open for the following nominees: Mark Alpers (Area 5), MJ Anderson (Area 12), David Meister (Area 14), and Julie Kim (Area 15). Motion: The GWNC selects Patricia Carroll (Area 10), Rory Cunningham (Area 10), Brian Curran (Area 14), Karen Gilman (Area 7), John Gresham (Area 13), Dick Herman (Area 10), Daniela Prowizor-Lacayo (Area 1), Jane Usher (Area 14), and Mark Alpers (Area 5) as members of the Land Use Committee, with Brian Curran as Committee Chair.

MOTION (by Mr. Gresham, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council selects Patricia Carroll (Area 10), Rory Cunningham (Area 10), Brian Curran (Area 14), Karen Gilman (Area 7), John Gresham (Area 13), Dick Herman (Area 10), Daniela Prowizor-Lacayo (Area 1), Jane Usher (Area 14), and Mark Alpers (Area 5) as members of the Land Use Committee, with Brian Curran as Committee Chair.
