

Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, September 13, 2023 Approved October 11, 2023

### I. WELCOMING REMARKS

A. Call to Order (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles, CA 90005. President Conrad Starr called the meeting to order at 6:31 p. m. and explained procedures. If there is a conflict-of-interest concern, contact Vanessa.Alvarado@LACity.org. Senate Bill 411, which would allow hybrid online/inperson meetings with restrictions, still is being considered by the State.

B. Flag Salute

The Pledge of Allegiance was led by Mr. Starr.

C. Roll Call (Jennifer DeVore)

The Secretary called the roll. Sixteen of the 21 Board Members or their Alternate(s) were present at the Roll Call: MJ Anderson (Alternate for Tommy Atlee), Selene Betancourt, Jeffry Carpenter, Cindy Chvatal-Keane, Romi Cortier, Brian Curran, Charles D'Atri (Vice-President), Jennifer DeVore (Secretary), Gary Gilbert, John Gresham, Jesseca Harvey, Julie Kim, Mark McQueen, Alex Nava, Sixto Sicilia and Conrad Starr (President). Patricia Carroll (Treasurer) arrived later. Scott Appel, Andy Galan, Benny Rosenberg and Owen Smith were absent and not represented by an Alternate. The GWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-board-rules), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). No Board Seat was vacant. Ten Alternate Seats were vacant [see Item #V. A. 2.; to apply see www.GreaterWilshire.org]. Also attended: 18 Stakeholders and guests.

## II. GOVERNMENT REPORTS & ANNOUNCEMENTS.

Board Member Patti Carroll arrived at this time (6:38), making 17 Board Members present (the GWNC quorum is thirteen).

A. Thirteenth Council District (Councilmember Hugo Soto-Martínez - councilmember.sotomartinez@lacity.org).

Councilmember Soto-Martinez [213-473-7013; https://cd13.LACity.org] described his Field Deputies' organizing experience. Homelessness-related issues are 40% of the calls to his Office; three Deputies are assigned to that issue. He introduced Homelessness Deputy Michael Batistick [Michael.Batistick@LACity.org]. Mr. Starr noted that some GWNC residents believe that "they're not being heard." The Councilmember replied "if that's happening, I want to know about it . . . they should be heard." There've been 6,000 eviction filings in CD13. He indicated that the 300 N. Plymouth party house nuisance is important to him. He explained that he called the City Attorney about it the same day he was notified of problems. He relayed that the City Attorney promised to have a Neighborhood Prosecutor work on it and a "coalition is trying to address shortcomings" in current law . . . We're looking at other Ordinances . . . Anything we can do, we're doing right now ... I want to be a partner ... I want this to end ... We're working with [State] Senator Durazo . . . Our Office is in contact with all levels of government . . . We should know the [City's] plan" for enforcement. The Councilmember described work to address transportation issues. "We're looking at Sunset as a possible bus-only corridor . . . We're looking at [the District] as a whole." The City is considering "public land" to provide housing; "we're looking at re-developing the Hollywood Community Plan . . . We should have a meeting about" the City's plans to greatly increase housing through upzoning. He believed that the Plan's housing numbers are too low.

L.A. City Fire Dept. Battalion 18 Chief Block reminded to ensure that smoke detectors work; batteries may need to be updated. He encouraged completing the CERT [Community Emergency Response Team; 818-756-9674; www.cert-la.com; lafdcert@LACity.org] program. The Fire Dept. is hiring people 18 and over; see JoinLAFD.org.

Sherwin Shamoeil, a Field Representative for State 51st District Assemblymember Rick Chavez Zbur [323-436-5184; Sherwin.Shamoeil@asm.ca.gov; https://a51.asmdc.org], reported that the Assemblymember voted in favor of SB411; now, the City Council needs to authorize it. Hybrid meetings may be allowed by November and "the Bill only covers two years." Regarding the 300 N. Plymouth party house, the Assemblymember's Office is collaborating with other officials. Only a single one-day alcohol license was issued for that address, but no more such licenses will be issued [to that address at this time].

Mr. Starr encouraged and Mr. Curran agreed to Agendize selection of a new Committee Chair. Also, the Metro Crenshaw Extension Line train may run up La Brea Ave.

Mr. Curran reported on the 531 N. Larchmont TOC project that "numerous" neighbors spoke with the Architect, who was "receptive" and will re-present to the Committee. He reported that Committee Member Jane Usher spoke about the need for developers to build according to agreed-upon plans. Mr. Gresham reported that the City is being requested to remove phrases such as "substantially like" from approved plans. Mr. Starr requested and Mr. Curran agreed that, when a letter to a developer is submitted for Board approval, the attachment(s) will be included. Ms. Roberts noted the importance of including document dates in such letters. Ms. Chvatal reported that the City said that communities must do "side agreements" with developers, not the City, but "they don't have any meaning . . . Planning doesn't care." The side agreement(s) must be in the Letter of Determination. There was discussion of how to get the CD5 Office involved, including CD5 Senior Planning Deputy Dylan Sittig [Dylan.Sittig@LACity.org].

*Ms.* Carroll's and Mr. Cortier's recusals ended and they returned to the room at this time, making 17 Board Members present (the GWNC Board quorum was thirteen).

B. 300 N. Plymouth Blvd: Nuisance Party House (Updates)

Resident Sam Uretsky reported that he may meet with a City Attorney about the above. Lately, there were three more parties, attended by 400 young people, with "people collecting cash at the door . . . [There were] drugs . . . It still remains a very serious problem." He said that Senior Lead Officer Pelayo told him that Officers are being trained to enforce a new Ordinance. Mr. Uretsky added that "nobody issued a Permit for this house" except for one. There were 19 calls to the Police regarding Labor Day party problems.
