

# Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, April 10, 2024 Approved May 8, 2024

#### I. WELCOMING REMARKS

A. Call to Order, Welcoming Remarks (Conrad Starr).

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles, CA 90005. President Conrad Starr called the meeting to order at 6:33 p. m. and explained procedures, reminding about checking with the City Attorney if a Board Member has a possible or definite conflict of interest.

## B. Roll Call (Jennifer DeVore).

Assistant Secretary Jessica Harvey called the roll. Twelve of the 20 Board Members or their Alternate(s) were present at the Roll Call, which is not a quorum: Tommy Atlee, Selene Betancourt, Cindy Chvatal-Keane, Romi Cortier, Brian Curran, Jesseca Harvey, Julie Kim, Sixto Sicilia, Owen Smith, Conrad Starr (President), David Trainer (Alternate for Jennifer DeVore) (Secretary) and Nicholas Wood (Alternate for John Gresham). Patricia Carroll (Treasurer), Charles D'Atri (Vice-President) and Gary Gilbert arrived later. Five Board Members were absent and not represented by an Alternate: Scott Appel, Jeffry Carpenter, Andy Galan, Alex Nava and Suzana Kim. The GWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-boardrules), so at this time the Board could only take public comments, could not have any official discussions, and could not make any Motions or take any votes. Twenty of the 21 Board Seats were filled (by election or appointment). One Board Seat was vacant [Area 4 - Fremont Place; see Item #V. A. 1.; to apply see www.GreaterWilshire.org]. Ten Alternate Seats were vacant [see Item #V. A. 2.]. Also attended: approximately 39 Stakeholders and guests.

Board Member Gary Gilbert arrived at this time (6:36), making 13 Board Members (or their Alternate(s)) present (the GWNC Board quorum is thirteen). Now the Board could take binding votes on Agendized Items. Board Members Charles D'Atri and Patti Carroll arrived at 6:38, making 15 Board Members (or their Alternate(s)) present.

One (Curran) was ineligible to vote due to not having completed one or more of the required trainings and/or not having signed the Code of Conduct.

## VIII. <u>AD HOC COMMITTEES</u> (Discussion and possible action).

- A. NPG Committee (Jesseca Harvey, Chair).
  - 1. Report/Committee Recommendations:
    - Recommend that award to HopeNet be \$875 to cover the purchase of food to stock the many food pantries within the GWNC's boundaries.
    - Recommend that award to LAUNCH be \$250 to cover production costs in the form of Artist Fees.
    - Recommend that award to FoodCycleLA be \$875 to cover the cost of purchasing supplies needed to transport and distribute the food such as: hand cart, bushel waxed produce boxes, Igloo thermoelectric iceless electric plug-in 12V cooler, and extra heavy duty grocery bags.

Ms. Harvey reviewed the above and said the total budget was \$2,000. These three were the only non-profits that applied.

2. HopeNet. Possible Motion: The GWNC awards up to \$4000 to HopeNet in the form of a Neighborhood Purposes Grant for purposes outlined in the application pending the (re)submission of the board and City required documentation with the modifications requested by the committee by Friday, April 12, 2024.

Ms. Harvey explained that the "Possible Motion" amounts were those organizations' requests; the Committee allocated lower amounts.

**FUNDING MOTION** (by Ms. Harvey, seconded by Mr. Atlee): The Greater Wilshire Neighborhood Council awards up to \$875 to HopeNet in the form of a Neighborhood Purposes Grant for purposes outlined in the application pending the (re)submission of the board and City required documentation with the modifications requested by the committee by Friday, April 12, 2024.

**FUNDING MOTION PASSED** by a roll call vote of the 14 eligible voters present with 13 in favor ("Yes" or "Aye") (Atlee, Betancourt, Carroll, Chvatal, Cortier, D'Atri, Gilbert, Gresham, Harvey, Julie Kim, Sicilia and Smith); zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Starr).

One (Curran) was ineligible to vote due to not having completed one or more of the required trainings and/or not having signed the Code of Conduct.

Possible Motion: The GWNC awards up to \$2500 to LAUNCH in the form of a Neighborhood Purposes Grant for purposes outlined in the application pending the (re)submission of the board and City required documentation with the modifications requested by the committee by Friday, April 12, 2024.

**FUNDING MOTION** (by Ms. Harvey, seconded by Ms. Betancourt): The Greater Wilshire Neighborhood Council awards up to \$250 to LAUNCH in the form of a Neighborhood Purposes Grant for purposes outlined in the application pending the (re)submission of the board and City required documentation with the modifications requested by the committee by Friday, April 12, 2024.

FUNDING MOTION PASSED by a roll call vote of the 14 eligible voters present with 12 in favor ("Yes" or "Aye") (Atlee, Betancourt, Carroll, Chvatal, Cortier, Gilbert, Gresham, Harvey, Julie Kim, Sicilia and Smith); zero opposed; two abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (D'Atri and Starr). One (Curran) was ineligible to vote due to not having completed one or more of the required trainings and/or not having signed the Code of Conduct.

4. FoodCycleLA. Possible Motion: The GWNC awards up to \$3001.99 to FoodCycleLA in the form of a Neighborhood Purposes Grant for purposes outlined in the application pending the (re)submission of the board and City required documentation with the modifications requested by the committee by Friday, April 12, 2024.

**FUNDING MOTION** (by Ms. Harvey, seconded by Ms. Betancourt): The Greater Wilshire Neighborhood Council awards up to \$875 to FoodCycleLA in the form of a Neighborhood Purposes Grant for purposes outlined in the application pending the (re)submission of the board and City required documentation with the modifications requested by the committee by Friday, April 12, 2024.

**FUNDING MOTION PASSED** by a roll call vote of the 14 eligible voters present with 13 in favor ("Yes" or "Aye") (Atlee, Betancourt, Carroll, Chvatal, Cortier, D'Atri, Gilbert, Gresham, Harvey, Julie Kim, Sicilia and Smith); zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Starr). One (Curran) was ineligible to vote due to not having completed one or more of the required trainings and/or not having signed the Code of Conduct.

5. Provisional Extension of Committee Mandate. Possible Motion: The NPG Ad Hoc Committee may bring further recommendations to the May 2025 General Board

Meeting regarding any remaining NPG budget resulting from the City Clerk's denial of any submitted applications.

It was noted that the year should be 2024, not "2025." Wording was added, as below, to the possible Motion.

**MOTION** (by Ms. Harvey, seconded by Ms. Betancourt): The Greater Wilshire Neighborhood Council approves that the NPG Ad Hoc Committee may bring further recommendations to the May 2024 General Board Meeting regarding any remaining NPG budget resulting from the City Clerk's denial of any submitted applications or failure by the applicants to submit revised applications per GWNC request.

**MOTION PASSED** unanimously by consent; zero opposed; zero abstained.

**IX. LAND USE COMMITTEE** (Discussion and possible action) (Chair: Brian Curran).

A. Committee Report on the March 26, 2024 Land Use Meeting. Mr. Curran reported.

[The following paragraphs before the made Motion are copied from the Agenda.] B. Motion to Amend a Motion Previously Adopted (Approved Item XV.B from 3/13/24).

Motion Previously Adopted on March 13, 2024 (Item XV. B.) "The GWNC supports the mayor's intent to expedite worthy 100% affordable projects, however we feel guidelines must be added to prevent problematic projects from being expedited as well. We feel the following guidelines should be added to the draft ordinance for ED1 as follows. The Greater Wilshire Neighborhood Council will file a CIS, directed to City Council and Committees, on the ED 1 Ordinance (CF 23-0623), listing its position as "For if Amended," and listing the guidelines sent by United Neighbors to the PLUM Committee, with a particular focus on the importance of the following required amendments: 1) to limit the number of waivers and off-menu incentives to a total of 6; 2) to require rear 15' setbacks to allow for trees to grow and stormwater to be captured; 3) to prevent postdevelopment conversion of nonresidential spaces to market rate units; 4) to protect R1, HPOZs, and identified historic districts in their entirety; 5) to ensure that substandard streets/high-fire zones do not qualify for ED 1 fast track approval; 6) to require that ED 1 projects meet minimum Tier 2 TOC qualifications; and 7) to require that all projects which do not meet these requirements under ED 1, including the above proposed amendments, go through discretionary approval."

Motion: The Greater Wilshire Neighborhood Council will modify the CIS previously presented to the Board (on 3/13/24) to add the following language to #4: "...and limit ED1 projects on NEIGHBORHOOD COMMERCIAL streets that abut, border, transect, or are adjacent to an R1 neighborhood to 4 stories".

[NOTE: Majority vote required to pass as written; <sup>2</sup>/<sub>3</sub> vote required if further amended.]

**MOTION** (by Mr. Curran, seconded by Mr. Sicilia): The Greater Wilshire Neighborhood Council will modify the CIS previously presented to the Board (on 3/13/24) to add the following language to #4: "...and limit ED1 projects on NEIGHBORHOOD COMMERCIAL streets that abut, border, transect, or are adjacent to an R1 neighborhood to 4 stories."

**MOTION to AMEND** (by Julie Kim, not seconded): The Greater Wilshire Neighborhood Council adds the words "or HPOZ" between the words "an R1 neighborhood" and "to 4 stories"

**MOTION to AMEND FAILED** for lack of a second.

**DISCUSSION**: Ms. Chvatal thought the Motion makes the GWNC appear to be against building more affordable housing. Mr. Gilbert believed that the Motion would make building affordable housing in Greater Wilshire "nearly impossible" and would cause the City "not to take the GWNC seriously." Residents Sam Uretsky and John Holloway, and a long-term Larchmont Village resident, supported the Motion; Todd Clemmons opposed it. A long-time Arden Blvd. resident said there's not enough infrastructure.

**MOTION FAILED** by a roll call vote of the 15 eligible voters present with four in favor ("Yes" or "Aye") (D'Atri, Harvey, Julie Kim and Sicilia); 10 opposed ("No" or "Nay") (Atlee, Betancourt, Carroll, Chvatal, Cortier, Curran, Gilbert, Gresham, Smith and Trainer); one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Starr).

Possible Motion: In light of neighbors' reports of illegal activities and criminal behavior by Manuel Funes aka Lucifer Rothschild reported both at the premises of 507 N. Larchmont Blvd. Los Angeles, CA 90004 and in the immediately adjacent neighborhood, and following the arrest on multiple felony counts of Mr. Funes, who occupied the premises at 507 N. Larchmont with the apparent knowledge of the property owner(s) from the beginning of December 2023 until his arrest on March 24, 2024 and incarceration on March 25, 2024, the Greater Wilshire Neighborhood Council requests the temporary suspension of approval by the Department of City Planning for any project planned or being planned at this address and the halting of the issuance of all permits, including but not limited to planning, building, filming, and public works permits for this address for 120 days or until the owners of 507 N. Larchmont Blvd. take appropriate steps to secure the property and safeguard the

neighborhood including the filing of a No Trespass Authorization Form with LAPD Wilshire Division, with the option authorizing the Los Angeles Police Department to arrest anyone on the property who is not a lawful resident, guest, or visitor and not exempted under L.A.M.C. 41.24(h) for a violation of L.A.M.C. 41.24(a), and post the property with the required conforming signage.

**MOTION** (by Mr. Trainer, seconded by Mr. Smith): The Greater Wilshire Neighborhood Council moves that, in light of neighbors' reports of illegal activities and criminal behavior by Manuel Funes aka Lucifer Rothschild reported both at the premises of 507 N. Larchmont Blvd. Los Angeles, CA 90004 and in the immediately adjacent neighborhood, and following the arrest on multiple felony counts of Mr. Funes, who occupied the premises at 507 N. Larchmont with the apparent knowledge of the property owner(s) from the beginning of December 2023 until his arrest on March 24, 2024 and incarceration on March 25, 2024, the Greater Wilshire Neighborhood Council requests the temporary suspension of approval by the Department of City Planning for any project planned or being planned at this address and the halting of the issuance of all permits, including but not limited to planning, building, filming, and public works permits for this address for 120 days or until the owners of 507 N. Larchmont Blvd. take appropriate steps to secure the property and safeguard the neighborhood including the filing of a No Trespass Authorization Form with LAPD Wilshire Division, with the option authorizing the Los Angeles Police Department to arrest anyone on the property who is not a lawful resident, guest, or visitor and not exempted under L.A.M.C. 41.24(h) for a violation of L.A.M.C. 41.24(a), and post the property with the required conforming signage.

**DISCUSSION**: Sam Uretsky showed photos of a broken door and window, overgrown front yard foliage, Mr. Funes on a roof looking into a neighbor's home; and videos of a fire in the house and the March 24th, 4:15 chase ending with the man "reaching thorough the broken window to open the [front] door." The next-door neighbor's property manager, Lauren Grant, said "my clients have been terrorized . . . it's been non-stop for six months." She said the 507 N. Larchmont Owner told her that he saw the video and didn't respond to any of the videos or photos and "to stop calling" him. She said the Owner "gave his permission" for the tenant to be on the roof "to help secure the property." She said neighbors have heard the tenant yelling. She said the door window was broken October 19th and that the owner still hadn't secured the property. She "was told that Lucifer is still in jail." She reported that there've been many trucks at the property and "people are constantly moving things in, moving things out." Resident Christopher Singh "got involved Sunday, March 24th"; he recounted that night's events. "This individual terrorized our neighborhood four times . . . the Owner had a relationship with this individual . . . [and] did not secure the property." Resident Serita Singh said "this man has broken into the home . . . [in a] multiple-day break-in." She described the man's unusual behavior and their fear of him. A "citizen's arrest" was made at 9:00 p.m.; she said "multiple homes . . . blocks were affected."

507 N. Larchmont property co-owner Sean Tabibian said his partner Shawn "has been very frustrated with this individual . . . Manuel Reyes is our maintenance guy . . . Lucifer ... is a serial burglar ... a known gang member ... He has broken into the property numerous times." Mr. Tabibian said he told the Police to remove Lucifer from the property and that "this individual is borderline crazy . . . We have secured the property . . . We're using [the property] as storage." He would be more than happy to get Lucifer off the property. He said that, when a property is boarded up, "it becomes a target . . . The property is secure . . . closed." He believed that posting a "No Trespassing" sign would prompt break-ins. Mr. D'Atri said "it is incumbent on the land owner to secure the property." Mr. Tabibian said "we've done everything we can to secure the property." He lives "very close to the neighborhood . . . I'm there every day." He said that, if they had someone living there, they'd have to turn on house services. He said "the problem has been mitigated by our employees going there every day . . . It's not feasible to have a 24-hour security guard." He promised that neighbors could contact him at any time on his cell at (310) 927-8811, and that he would contact the Wilshire Division SLO to file a No Trespass Authorization Form for the property.

**MOTION to AMEND** (by Mr. Gilbert, seconded by Ms. Chvatal): The Greater Wilshire Neighborhood Council inserts the following wording to the Motion between the words "take" and "appropriate": "what this Board believes to be," so that that part of the amended Motion would read ". . . or until the owners of 507 N. Larchmont Blvd. take what this Board believes to be appropriate steps . . ."

**MOTION to AMEND PASSED** unanimously by a hand vote; zero opposed; zero abstained.

**AMENDED MOTION PASSED** by a hand vote with 12 in favor; zero opposed; three abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Atlee, Betancourt and Starr).

B. Draft 2025 Neighborhood Council Election Timeline and Handbook. Possible Motion: The GWNC [see below].
