

Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, February 14, 2024 Approved March 13, 2024

Pursuant to the October 6, 2023 enactment of California Senate Bill 411 (Portantino) and LA City Council approval on November 1, 2023, the Greater Wilshire Neighborhood Council meeting will be conducted virtually.

## I. WELCOMING REMARKS

A. Call to Order, Welcoming Remarks (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held online. President Conrad Starr called the meeting to order at 6:32 p. m. and explained procedures.

B. Roll Call (Jennifer DeVore)

The Secretary called the roll. Nineteen of the 20 Board Members or their Alternates were present online at the Roll Call: Mark Alpers (Alternate for Brian Curran), MJ Anderson (Alternate for Tommy Atlee), Scott Appel, Selene Betancourt, Jeffry Carpenter, Patricia Carroll (Treasurer), Cindy Chvatal-Keane, Romi Cortier, Charles D'Atri (Vice-President), Jennifer DeVore (Secretary), Andy Galan, Gary Gilbert, John Gresham, Jesseca Harvey, Julie Kim, Alex Nava, Cathy Roberts (Alternate for Sixto Sicilia), Owen Smith and Conrad Starr (President). Suzana Kim was absent and not represented by an Alternate. The GWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https:// greaterwilshire.org/bylaws-board-rules), so the Board could take such votes. Twenty of the 21 Board Seats were filled (by election or appointment). One Board Seat was vacant [Area 4 – Fremont Place; see Item #V. A. 1.; to apply see www.GreaterWilshire.org]. Eight Alternate Seats were vacant [see Item #V. A. 2.]. Also attended: approximately 29 Stakeholders and guests.

## II. GOVERNMENT REPORTS & ANNOUNCEMENTS.

A. Fifth Council District (Michelle Flores - Michelle.Flores@LACity.org)

Michelle Flores, a Field Deputy for L.A. City District Five Councilmember Katy Yaroslavsky [ofc. 213-473-7005; https://councildistrict5.LACity.gov], reported that a speed bump on Norton will be reinstalled and graffiti at 133 N. La Brea will be cleared.

B. Thirteenth Council District (Field Deputy Karla Martinez - karla.g.martinez@LACity.org)

Karla Martinez, a Field Deputy for L.A. City District 13 Councilmember Hugo Soto Martinez [213-473-7013; https://cd13.LACity.org], reported that the City is working to repair street light outages, which're usually due to copper wire theft. Downed palm fronds from the recent storm are being collected. LADOT will add center markings on Larchmont Blvd. and may add more parking meters.

C. LAPD Olympic & Wilshire Divisions (SLOs Cho, Pelayo, Rodriguez) Joshua Parker, an LAPD Wilshire Division Acting Senior Lead Officer [38959@LAPD.Online; https://www.LAPDOnline.org/lapd-contact/west-bureau/wilshire community-police-station], (for Dave Cordova, who retired), introduced himself and described his coverage area. He reported that recent crime statistics "are at an all-time low." He described a recent apprehension and that unhoused services were provided.

Harry Cho, an LAPD Olympic Division Senior Lead Officer [office 213-382-9102; cell/ text phone 213-793-0649; 33817@LAPD.Online; http://www.LAPDonline.org/ olympic\_community\_police\_station], reported that "a recent rise" in burglaries "of condos and apartments, smashing the sliding glass windows . . . and ransacking the residence[s]"; they may be using ladders. He described "several crews" doing it. The crews' license plates may be stolen from other vehicles. Kias and Hyundais are top two stolen vehicles: "there is a software update . . . the dealer . . . will update your vehicle." He described that an inter-agency task force has "made numerous arrests." The State may consider repealing Prop 47.

Larchmont Blvd.

**MOTION PASSED** unanimously by a hand vote with all 19 in favor; zero opposed; zero abstained.

C. 507 N. Larchmont Blvd (ED1 Project): Demolition of existing uses and the construction, use, and maintenance of a new 7-story, mixed use building, containing a 100% affordable housing project, consisting of 52 units (inclusive of 1-market rate manager's unit) with 1-Very Low Income (VLI), 40-Low Income (LI), and 10-Moderate Income (MI) units, as well as 845 sf. of ground floor Commercial Retail use. Filing Date: 12/14/23. Zoning: [Q]C2-1VL. Case no: ADM-2023-8207-DB-HCA-ED1. Possible Motion: WHEREAS, the applicant has proposed a project located within the GWNC at 507 N. Larchmont Boulevard seeking to build a "New 7-story Mixed Use building including 52 Unit 100% Affordable Apartments and Retail Space Under City of Los Angeles ED1 Ordinance and AB 1763 Including occupied Roof Top Open Space Over 5 Level (Type III-A) R-2 Occ. Over 2-Level (Type I-A) R-2/S-2/M Occ. Fully Sprinklered NFPA-13", with zero parking, 13 large recreation rooms, and 52 smaller studio apartments; and WHEREAS, the project application identifies ED1 and AB 1763 as the legal bases for its 7 stories and zero parking, and the 52 studio apartments as the legal basis for its ED1 eligibility, but we have concerns that: (a) the maximum permitted height, if the project is factually demonstrated to qualify for a height bonus, incentive or waiver, may be an additional 33 feet and three stories on top of the maximum 45 feet and three stories otherwise permitted by the underlying [Q]C2-1VL Zone, for a total maximum project height of 78 feet and six stories (not seven stories); (b) the project may not actually be located within one-half mile of a Major Transit Stop and therefore may not qualify for any bonus, incentive or waiver in project height or in parking reduction on the basis of such a Major Transit Stop; and (c) the project may not be a 100% affordable housing project as claimed but rather may be intended for the

conversion of 25% of the project into 12 or 13 Accessory Dwelling Units for rent or sale at market rates; and WHEREAS, the GWNC LUC timely reached out to project representatives to attend its meeting at which the questions regarding height, zero parking, the recreation rooms and their conversion to market-rate housing, severely reduced setbacks, proximity to R-1 zoned properties, front and rear-facing balconies, and the open rooftop deck proposed by the project could be discussed and understood, modified or rejected, but the project representatives were not in attendance at this meeting; and WHEREAS, the applicant seeks project approval within sixty (60) days as an Administrative or Ministerial decision, offering no opportunity for public input,

Greater Wilshire Neighborhood Council Gen'l Bd Mtg Minutes 2-14-24 Pg. 8 of 18 hearing, or appeal, making time of the essence in this matter; NOW THEREFORE, the GWNC Land Use Committee moves that the GWNC Board take action to voice its strong support for 100% affordable housing projects in our neighborhood and to further oppose this project at 507 N. Larchmont Boulevard until such time as the questions about the project raised in this Motion, including but not limited to the lawful bases for the proposed project height, zero parking, and claim of 100% affordable housing, are satisfactorily answered.

The Motion was revised as follows, beginning with the deletion of the wording six lines from the end: "the GWNC Land Use Committee moves that."

**MOTION** (by Mr. Alpers, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council Motions that WHEREAS, the applicant has proposed a project located within the GWNC at 507 N. Larchmont Boulevard seeking to build a "New 7story Mixed Use building including 52 Unit 100% Affordable Apartments and Retail Space Under City of Los Angeles ED1 Ordinance and AB 1763 Including occupied Roof Top Open Space Over 5 Level (Type III-A) R-2 Occ. Over 2-Level (Type I-A) R-2/S-2/M Occ. Fully Sprinklered NFPA-13", with zero parking, 13 large recreation rooms, and 52 smaller studio apartments; and WHEREAS, the project application identifies ED1 and AB 1763 as the legal bases for its 7 stories and zero parking, and the 52 studio apartments as the legal basis for its ED1 eligibility, but we have concerns that: (a) the maximum permitted height, if the project is factually demonstrated to qualify for a height bonus, incentive or waiver, may be an additional 33 feet and three stories on top of the maximum 45 feet and three stories otherwise permitted by the underlying [Q]C2-1VL Zone, for a total maximum project height of 78 feet and six stories (not seven stories); (b) the project may not actually be located within one-half mile of a Major Transit Stop and therefore may not qualify for any bonus, incentive or waiver in project height or in parking reduction on the basis of such a Major Transit Stop; and (c) the project may not be a 100% affordable housing project as claimed but rather may be intended for the conversion of 25% of the project into 12 or 13 Accessory Dwelling Units for rent or sale at market rates; and WHEREAS, the GWNC LUC timely reached out to project representatives to attend its meeting at which the questions regarding height, zero parking, the recreation rooms and their conversion to market-rate housing. severely reduced setbacks, proximity to R-1 zoned properties, front and rear-facing balconies, and the open rooftop deck proposed by the project could be discussed and

understood, modified or rejected, but the project representatives are not in attendance at this meeting; and WHEREAS, the applicant seeks project approval within sixty (60) days as an Administrative or Ministerial decision, offering no opportunity for public input, hearing, or appeal, making time of the essence in this matter; NOW THEREFORE, the GWNC Board voices its strong support for 100% affordable housing projects in our neighborhood and to opposes this project at 507 N. Larchmont Boulevard until such time as the questions about the project raised in this Motion, including but not limited to the lawful bases for the proposed project height, zero parking, and claim of 100% affordable housing, are satisfactorily answered.

**AMENDMENT to the MOTION FAILED** by a roll call vote of the 19 eligible voters present with six in favor ("Yes" or "Aye") (Appel, Betancourt, Carpenter, Cortier, Gilbert and Smith); seven opposed ("No" or "Nay") (Alpers, Anderson, Carroll, Chvatal, D'Atri, DeVore and Starr); six abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Galan, Gresham, Harvey, Julie Kim, Nava and Roberts).

**DISCUSSION**: Mr. D'Atri referred commenters "to write to their Councilperson," whether CD13 or CD5. He urged people to comment in person if allowed at a public Hearing. Resident Sam Uretsky reported that "hundreds" of neighbors oppose this project.

**ORIGINAL MOTION PASSED** by a roll call vote of the 19 eligible voters present with 15 in favor ("Yes" or "Aye") (Alpers, Appel, Carpenter, Carroll, Chvatal, Cortier, D'Atri, DeVore, Gilbert, Gresham, Harvey, Julie Kim, Nava, Roberts and Smith); two opposed ("No" or "Nay") (Anderson and Galan); two abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Betancourt and Starr). One (Roberts) was ineligible to vote due to not having completed one or more of the required trainings and/or not having signed the Code of Conduct.

D. 800 S. Lorraine Blvd (ED1 Project): The construction of a new 29,785 sf, 6-story, 100% affordable housing apartment building, with 70 dwelling units (28 studio apts. and 42 one-bedroom apts), including 55-Low Income (LI) units, 14-Moderate Income (MI) units, and 1-manager's unit, on a 7,856 sf vacant lot in the [Q]R3-1-HPOZ zone, within the Windsor Village Historic Preservation Overlay Zone (HPOZ). Filing Date: 12/22/23. Case no: ADM-2023-8417-DB-VHCA-ED1. Possible Motion: [see below].

**MOTION** (by Mr. Alpers, seconded by Mr. Gresham): The Greater Wilshire Neighborhood Council voices its strong support for 100% affordable housing projects in our neighborhood and further opposes this project at 800 S. Lorraine Boulevard (the construction of a new 29,785 sf, 6-story, 100% affordable housing apartment building, with 70 dwelling units, 28 studio apartments and 42 one-bedroom apartments, including 55-Low Income (LI) units, 14-Moderate Income (MI) units, and 1-manager's unit, on a 7,856 sf vacant lot in the [Q]R3-1-HPOZ zone, within the Windsor Village Historic Preservation Overlay Zone, Filing Date: 12/22/23, Case no: ADM-2023-8417-DB VHCA-ED1), until such time as the many questions about the project raised in the LUC meeting, including but not limited to the project's location in an HPOZ, the project inconsistencies identified in the City's letter dated January 19, 2024, and the neighbors' concerns regarding height, setbacks, building line, dedications, the lack of trees, the plan for trash, recycling and organic waste pickup, and the narrowness of their street, are satisfactorily answered.

DISCUSSION: Project representative Gary Benjamin, of Albany Planning and Land Use, presented. He showed slides and described the project. Ms. Chvatal believed this project "does not fit in the neighborhood." Mr. Gresham noted "we've seen nothing in writing that addresses these questions" from the GWNC. Mr. Galan believed it to be "disingenuous" that the GWNC says it "supports 100% affordable housing" but opposes this project. Mr. Nava "do[es] question the Board's commitment to affordable housing." Mr. Starr believed trash bins would have to be put in the street for pickup.

Windsor Village Resident Lorraine Wild said "what you're (Mr. Benjamin) showing tonight is diff from what we all saw . . . how can you justify it?" Mr. Benjamin said "there's a mix of styles and sizes" of nearby buildings, while none of them are 100% affordable as this one would be. Mr. Sapunor believed project to big.

Board Member Gary Gilbert stepped away this time (9:08), making 18 Board Members present online (the GWNC Board quorum is thirteen).

**MOTION** (by Mr. Alpers, seconded by Ms. DeVore): The Greater Wilshire Neighborhood Council opposes the project for a proposed 24-hour convenience store and gas station with alcohol sales at 1009 Crenshaw Blvd. as presented on January 23, 2024.

**DISCUSSION**: Mr. Gresham reported that "the neighbors are activity pursuing commenting on this project . . . there is a 7-Eleven in GWNC that sets a precedent and

does not sell alcohol." Mr. Starr encouraged the Committee to further consider the project. Clyde Lieberman indicated that two neighborhood associations indicated to the City that they opposed the project. Mr. Gresham "it's a full line" of alcohol being proposed to sell.
