

Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, May 8, 2024 Approved July 10, 2024

Pursuant to the October 6, 2023 enactment of California Senate Bill 411 (Portantino) and LA City Council approval on November 1, 2023, the Greater Wilshire Neighborhood Council meeting will be conducted virtually.

I. WELCOMING REMARKS

A. Call to Order, Welcoming Remarks (Conrad Starr).

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held online. President Conrad Starr called the meeting to order at 6:30 p. m. and explained procedures, reminding about checking with the City Attorney if a Board Member has a possible or definite conflict of interest.

B. Roll Call (Jennifer DeVore).

The Secretary called the roll. Seventeen of the 20 Board Members or their Alternate(s) were present online at the Roll Call: Mark Alpers (Alternate for Brian Curran), Scott Appel, MJ Anderson (Alternate for Tommy Atlee), Selene Betancourt, Jeffry Carpenter, Cindy Chvatal-Keane, Romi Cortier, Charles D'Atri (Vice-President), Jennifer DeVore (Secretary), Andy Galan, Gary Gilbert, John Gresham, Jesseca Harvey, Julie Kim, Sixto Sicilia, Owen Smith and Conrad Starr (President). Patricia Carroll (Treasurer) arrived later. Suzana Kim and Alex Nava was absent and not represented by an Alternate. New Area 4 - Fremont Place Board Member Anne Rudnick was appointed during below Item #V. 3. A. The GWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https:// greaterwilshire.org/bylaws-board-rules), so the Board could take such votes. Twenty of the 21 Board Seats were filled (by election or appointment). One Board Seat was vacant [Area 4 - Fremont Place]. Ten Alternate Seats were vacant [see Item #V. A. 2; to apply see www.GreaterWilshire.org]. Also attended: approximately 25 Stakeholders and guests.

II. GOVERNMENT REPORTS & ANNOUNCEMENTS

A. Fifth Council District (Michelle Flores - michelle.flores@lacity.org). Michelle Flores, a Field Deputy for L.A. City District Five Councilmember Katy Yaroslavsky [ofc. 213-473-7005; Michelle.Flores@LACity.org; https:// councildistrict5.LACity.gov], reported that the City budget is being considered, and on upcoming events. Mr. Starr said more information is on the GWNC website.

Board Member Brian Curran arrived at this time (6:39), replacing his Alternate Mark Alpers, keeping 17 Board Members present (the GWNC Board quorum was thirteen). Then Board

Ms. DeVore reported regarding tree maintenance at 324 S. June St.

- B. Thirteenth Council District (Karla Martinez karla.g.martinez@lacity.org). Karla Martinez, a Field Deputy for L.A. City District 13 Councilmember Hugo Soto Martinez [213-473-7013; https://cd13.LACity.org], reported that street light funding was identified; repairs are forthcoming. She urged reporting outages. They collaborated with LAUSD to install speed humps by two CD13-area schools. She explained homelessness service work. Regarding the Larchmont Blvd. illegal center turn lane parkers, they will ask for more LAPD enforcement for that and for homeless encampment illegal drug use. Mr. Starr asked for more than "double-parking" citations to be issued to those illegal parkers. Ms. Martinez will check with LAPD regarding installing more traffic signage. Senior Lead Officer Harry Cho said "99% of encampments have [illegal] drug use."
- C. LAPD Olympic & Wilshire Divisions (SLOs Cho 33817@lapd.online & Pelayo 31762@lapd.online (Olympic), Rodriguez (Wilshire)).

Harry Cho, an LAPD Olympic Division Senior Lead Officer [office 213-382-9102; cell/ text phone 213-793-0649; 33817@LAPD.Online; http://www.LAPDonline.org/ olympic_community_police_station], reported that laptops, cellphones and more are being stolen from vehicles that are unlocked and/or windows are broken. He encouraged reporting if you see a group of young people walking on a sidewalk wearing hoodies in the middle of the day. He described law enforcement regarding encampment cleanups and illegal drug use. Some housed formerly homeless people "come back" to "hang out" and consume illegal drugs with former homeless neighbors.

Hebel Rodriguez, an LAPD Wilshire Division Senior Lead Officer [office 213-473-0476; cell/text phone 213-793-0715; 35738@LAPD.Online; https://www.LAPDOnline.org/ lapd-contact/west-bureau/wilshire-community-police-station], reported that Mayor Bass is asking each Division what qualities and who should be the next LAPD Chief. He "will notify our Traffic Division Officers to have them address that issue" of Larchmont Blvd. illegal center turn lane parkers and have other officers help with enforcement and "extra patrol . . . We can cite them [for a moving violation] . . . if they're behind the driver's seat." He also will contact LADOT to "address that." Robberies are "down 5% compared to last year . . . Burglaries . . . almost [a] 28% decrease . . . Stolen vehicles . . . [a] 3.4% decrease . . . Car break-ins . . . [a] 22.6% increase year-to-date . . . Even change in the center console . . . they're going to smack your window . . . [Keep it] out-of-sight, out-of-mind . . . Remove valuables from vehicles [had a] 100% increase . . . Thefts . . . [a] 22.7% increase . . . Make sure that when you're in stores . . . do not leave items unattended . . . Take your items with you." Officer Phillip Choy will be covering for Dave Cordova; Officer Choy is at 213-793-0650; 38788@LAPD.Online.

Ned Racine, Metro Principal Construction Relations Officer [cell 213-418-5993, RacineN@metro.net; 24-hour information 213-922-6934; Bus Rapid Transit 24-hour hotline 213-922-2500+1; PurpleLineExt@metro.net; www.facebook.com/PurpleLineExt; www.Twitter.com/PurpleLineExt; www.metro.net/PurpleLineExt], noted work at LaBrea and Fairfax; a new bus lane on Fairfax at Wilshire, and on Wilshire west of LaBrea. MOTION (by Mr. Gresham, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council appoints Anne Rudnick to the Area 4 - Fremont Place Director seat.

DISCUSSION: Resident Patty Lombard supported Ms. Rudnick's candidacy, which was unanimously supported by the Fremont Place Board.

 Ms. Harvey nominated Dan Sterling. Resident Mr. Sterling accepted the nomination, introduced himself and described his interest in serving the community. There were no other nominations.

MOTION (by Ms. DeVore, seconded by Ms. Harvey): The Greater Wilshire Neighborhood Council appoints Dan Sterling to the Area 11- Sycamore Square Alternate Seat.

MOTION PASSED by a roll call vote of the 19 eligible voters present with 18 in

New Board Member Anne Rudnick was allowed to vote in the above and below Motions, then joined in (see below) to read aloud the Oath of Office.

c) Robert (Bob) Reeves, Candidate for Area 10 - Ridgewood-Wilton/St. Andrews Square Alternate seat.

Ms. Carroll nominated Bob Reeves. Resident Mr. Reeves, a former GWNC Board Alternate, accepted the nomination, introduced himself and described his interest in serving the community. There were no other nominations.

MOTION (by Mr. Smith, seconded by Ms. Chvatal): The Greater Wilshire Neighborhood Council appoints Bob Reeves to the Area 10 - Ridgewood-Wilton/St. Andrews Square Alternate seat.

MOTION PASSED by a roll call vote of the 19 eligible voters present with 18 in favor ("Yes" or "Aye") (Anderson, Appel, Betancourt, Carpenter, Carroll, Chvatal, Cortier, Curran, D'Atri, DeVore, Galan, Gilbert, Gresham, Harvey, Julie Kim, Rudnick, Sicilia and Smith); zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Starr).

Mr. Starr indicated that there were no more nominations. Resident Amy Zimmerman, who also lives in Area 10 - Ridgewood-Wilton/St. Andrews Square, introduced herself; Board Members encouraged her to consider Committee membership.

New Board Member Anne Rudnick was Seated at this time, making 19 Board Members (or their Alternate(s)) present online (the GWNC Board quorum is thirteen).

Please check EmpowerLA.org/GWNC for your training expirations and email secretary@greaterwilshire.org if there are any inconsistencies. 1. Per DONE: "All Board and Committee members must complete the ABLE and Gender Expression and Gender Identity trainings, and acknowledge the amended Code of Conduct, no later than Monday June 3, 2024. The trainings and Code of Conduct acknowledgement are available on the Cornerstone platform. Failure to complete these trainings or acknowledge the amended Code of Conduct prior to June 3rd will result in ineligibility to vote on funding and non-funding items in committee and general board meetings. Following the June 3rd deadline, newly elected, appointed, or selected Board and Committee members will have 30 days to acknowledge the Neighborhood Council Code of Conduct.

Ms. DeVore and Mr. Starr noted the above; see EmpowerLA.Rosters@gmail.com. Mr. Starr relayed that DONE said that Committee Members do not need to complete Cornerstone training, but still must complete the Ethics Training and sign the Code of Conduct.

Recusing is not the same as abstaining from voting, which is declining to vote "yes" or "no." He also turned over the Presiding Officership to Mr. D'Atri at this time.

VIII. LAND USE COMMITTEE (Discussion and possible action) (Chair: Brian Curran)

A. Committee Report on the April 23, 2024 Land Use Meeting.

Mr. Curran reported that there was a "very animated discussion . . . the property owner [of 507 N. Larchmont] showed up and answered a lot of questions."

[*The following paragraphs through "Possible Motion" are copied from the Agenda.*] B.

800 S. La Brea Ave (All Season Brewing Co): On 4/12/17, the GWNC supported the application for a CUB for the brewpub at 8th and La Brea in the former Firestone building, which opened several years later, during the pandemic, as the All Season Brewing Co - the GWNC support was "As presented with the conditions negotiated with the Sycamore Square Neighborhood Association (SSNA)". The approved CUB lists several items that were requested to be included by the applicant and which align with the conditions negotiated with the SSNA. However, pertaining to the full list of conditions, the following items are seemingly not being adhered to and may or may not deserve a review with the business ownership or management:

- 21: Any music, sound, or noise emitted from the premise, including outdoor patio area must not be audible beyond the property line of the premise.
- 22: There shall be no advertisement or sign of any kind or type promoting or indicating the availability of alcoholic beverages on the exterior of the premise, including advertising directed to the exterior from within.
- 28: Applicant shall not allow the premises to be used for private parties.

Furthermore, by measurements taken, the fenced in outdoor area extends well into the public right of way/sidewalk: the property line according to the plans in the CUB is 183" from the curb to the west of the building and to the north; however, the fence on the west side is at approximately 120" from the curb (63" into the public right of way) and 90" from the curb on the north, or 93" into the public right of way.

Possible Motion: The Greater Wilshire Neighborhood Council [see below Motion].

It was reported that company representatives "negotiated with the Sycamore Square Neighborhood Association," however, next-door neighbor Dr. Ash had told the Committee of multiple violations by the business and its customers.

MOTION (by Mr. Curran, seconded by Mr. Gresham): The Greater Wilshire Neighborhood Council will send letters to CD 5 and the owners of All Season Brewing Co. at 800 S. La Brea Ave. regarding the concerns of neighbors and the adjacent homeowners about violations of the CUB, asking them to come into compliance, and requesting that they attend a GWNC Land Use Committee meeting to discuss this matter.

DISCUSSION: Dr. Ash reported that "since 2020 they've broken every single thing on [the conditions] list" and communicated "very rudely" with him; "they have zero respect for the residents . . . Their parking situation is atrocious . . . They said "too bad, talk to the City." He said there's "no security" on the Eighth St. side. There's outside smoking, public urination and "way more" by their customers. Public space has been appropriated by the bar. Mr. Starr, speaking as an individual resident, described problems reported to him about the bar, noting that he, Mr. Starr, reported problems to the City. Proprietor Brian Lenzo reported that outside audio speakers were removed and described other mitigations. He stated that "if there's a problem for the neighborhood, we're happy to

remove it . . . We're 100% on it . . . We're happy to have that meeting with you." Resident Liz Fuller reported that neighbors communicated problems to ownership at least two years ago; "this has been an ongoing problem." Mr. Lenzo said "I'm sorry if anybody spoke to you that way . . . That manager has been removed." Mr. Lenzo offered his contact information.

CALL for the QUESTION (by Mr. D'Atri): **PASSED** by consent; zero opposed; zero abstained.

MOTION PASSED unanimously by a hand vote with all 18 in favor; zero opposed; zero abstained. One recused and was ineligible to vote (Starr).

 - The Earth Day Fair was successful. The partnership with CD 5 worked very well. There were 4 booths for kid activities: HODG Arts & Crafts, HODG Plant Native Seeds, GWNC Renewable Energy Toys, and GWNC Climate Game. Roughly 100 people attended. GWNC members from the Sustainability and Outreach Committees and the President attended and staffed the GWNC booth. Working with CD5, the GWNC Sustainability Committee and HODG to improve the event for next year. Earth Day Fair cost was \$99.18 for popsicles, bananas, and oranges. The budget allocated for food was \$100.

Ms. Flores described the "great" event. Ms. Estabrook reported that there were 14 booths; volunteers mostly were from Campbell Hall. Youths showed "renewable energy toys" to other youths. She thanked GWNC volunteers and CD5 and noted that "all this was accomplished with 99 dollars."

3. A Special Meeting of the Committee was scheduled on Friday, May 3rd to discuss possible budget request for 2024-2025, however a quorum was not met. A rough event

MOTION (by Ms. DeVore, seconded by MJ Anderson): The Greater Wilshire Neighborhood Council will file a CIS on Council File 24-0055, directed to City Council and Committees, listing its position as "for," expressing its full support for the council file, as the particulate matter and CO2 emissions of gas powered leaf blowers are now better quantified and their negative impacts are now better understood, and the still much needed 1998 ordinance has not been effectively implemented.

DISCUSSION: Ms. DeVore explained that the Hancock Park Homeowners Association offered a \$100 credit to homeowners who'd switch from gas to electric-powered leaf blowers. The draft CIS (Community Impact Statement) was shown online. Mr. Gilbert relayed that his gardener was concerned about cost, practicality and securing the batteries from theft. Various Board Members were concerned about who would enforce it.

Board Members Jesseca Harvey and Sixto Sicilia had left by this time, making 15 Board Members present online (the GWNC Board quorum is thirteen).

MOTION PASSED by a roll call vote of the 15 eligible voters present with eight in favor ("Yes" or "Aye") (Anderson, Appel, Betancourt, Curran, DeVore, Galan, Julie Kim and Rudnick); five opposed ("No" or "Nay") (Carroll, D'Atri, Gilbert, Gresham and Smith); two abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Cortier and Starr).
