

# Greater Wilshire Neighborhood Council General Board Meeting Minutes, Wednesday, July 10, 2024 Approved September, 2024

## I. WELCOMING REMARKS

A. Call to Order, Welcoming Remarks (Conrad Starr)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles, CA 90005. President Conrad Starr called the meeting to order at 6:34 p.m. and explained procedures, reminding about checking with the City Attorney if a Board Member has a possible or definite conflict of interest.

B. Flag Salute
The Pledge of Allegiance was said.

#### C. Roll Call (Jennifer DeVore)

Assistant Secretary Jesseca Harvey called the roll. Ten of the 19 Board Members or their Alternate(s) were present at the Roll Call, which is not a quorum: Tommy Atlee, Jeffry Carpenter, Cindy Chvatal-Keane, John Gresham, Jesseca Harvey (Assistant Secretary), Sixto Sicilia, Owen Smith, Conrad Starr (President), David Trainer (Alternate for Jennifer DeVore, Secretary) and John Winther (Alternate for Romi Cortier). Scott Appel, Patricia Carroll (Treasurer), Charles D'Atri (Vice-President) and Julie Kim arrived later. Six Board Members were absent and not represented by an Alternate: Selene Betancourt, Brian Curran, Andy Galan, Gary Gilbert, Benny Rosenberg and Anne Rudnick. Alex Nava (in July) and Suzana Kim (in June) had resigned. The GWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 13 (see the Bylaws link at https://greaterwilshire.org/bylaws-board-rules), so at this time the Board could only take public comments, could not have any official discussions, and could not make any Motions or take any votes. Nineteen of the 21 Board Seats were filled (by election or appointment). One Board Seat was vacant [Area 9 -Oakwood-Maplewood-St Andrews; see Item #V. A. 2.] and ten Alternate Seats were vacant [see Item #V. B. 1.; to apply see www.GreaterWilshire.org]. Also attended: 12 Stakeholders and guests.

Harry Cho, an LAPD Olympic Division Senior Lead Officer [office 213-382-9102; cell/text phone 213-793-0649; 33817@LAPD.Online; http://www.LAPDonline.org/olympic\_community\_police\_station], introduced Danny Chavez, an Olympic Division Senior Lead Officer [office 213-382-9102; cell/text phone 213-793-0649 (the same as retired Officer Joe Pelayo); 36304@LAPD.Online], who replaced Officer Pelayo. Officer Cho described outreach to homeless people, saying "we've made all the efforts we can; now it's enforcement . . . Eight were housed, but there were some holdouts."

Board Member Patti Carroll arrived at this time (6:41), making 13 Board Members present (the GWNC quorum was thirteen). Now the Board could take binding votes on Agendized Items.

Officer Cho continued reporting. Gang members have attacked homeless people. He will distribute a "Use of Force Report"; it's around 120 pages. Officer Chavez reported that he's been a Senior Lead Officer for 14 years, including in the Olympic Division in 2009. He described that he wanted to be in Greater Wilshire.

Board Members Julie Kim and Andy Galan arrived at this time (6:47), making 15 Board Members present (the GWNC quorum is thirteen).

Officer Cho announced that National Night Out [https://natw.org] will be Tuesday, August

Savannah Portillo Heap, a Field Deputy for L.A. County District Three Supervisor Lindsey Horvath (213-440-0927; https://lindseyhorvath.LACounty.gov], reported that the County's annual budget was approved and is online. Proposals were made for the biggest County government reform "in a century": the Chief Executive would be elected, and the Board of Supervisors would expand from five to nine Seats. Also, an independent Ethics Commission would be appointed. Those proposals will be considered at July 23<sup>rd</sup> and August 6<sup>th</sup> public Board meetings for approval. Proposals passed wouldn't be effective until 2032.

## H. Other Government Representatives

L.A. City Fire Dept. Battalion 18 Chief Lance McCloskey (Lance.McCloskey@LACity.org; LAFDBattalion18@LAFD.org) reported that Greater Wilshire is covered by three Battalions. He cautioned about heat exhaustion and heat stroke, describing dehydration symptoms. If someone is hot but not sweating and/or is dizzy, they could be having a stroke; call 9-1-1. He encouraged drinking plenty of water, staying in shade, wearing light-colored clothing, and more. Cooling centers are available.

Joshua Marin-Mora, a representative for State 51st District Assemblymember Rick Chavez Zbur [323-436-5184; https://a51.asmdc.org], updated about legislation and funding secured for housing, the environment and more.

## VIII. LAND USE COMMITTEE (Discussion and possible action)

Mr. Gresham reported for Mr. Curran that the Committee "had a short, very productive meeting."

B. City Implementation of Senate Bill 4: The City of LA may revise its implementation of SB 4 in a way that allows for 100% affordable housing projects in R-1 zoned sites and HPOZs on land owned by faith-based organizations. Motion: The Greater Wilshire Neighborhood Council [see the below Motion]

Mr. Gresham explained the Motion.

MOTION (by Mr. Gresham, seconded by Ms. Chvatal): The Greater Wilshire
Neighborhood Council supports the "time of ownership" requirement in SB 4 that
allows for 100% affordable housing projects by faith-based organizations on property
owned by these organizations prior to January 1, 2024 and opposes the City Planning
Department's proposed elimination of this time of ownership requirement as part of the
Planning Department's Citywide Housing Incentive Program (CHIP) because the "time
of ownership" restriction was a fundamental limitation that allowed SB 4 to be enacted
and its elimination will allow faith-based organizations, new and old, and their partners
to become housing speculators rather than centers for worship.

**MOTION PASSED** by a hand vote with 11 in favor (Carpenter, Carroll, Chvatal, D'Atri, Gresham, Harvey, Kim, Sicilia, Smith, Trainer and Winther); two opposed (Atlee and Galan); two abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Appel and Starr).

C. 460 S. La Brea Ave (former La Brea Bakery location): Filing date: 3/26/24. A CUB to continue the sale and dispensing of a full-line of alcohol for on-site consumption in conjunction with a 4,465 sf restaurant (Leopardo) with 130 seats, and 459 sf patio with 26 seats, that includes the request for a deviation from the operating hours for a commercial corner development from 7am-12am, daily. Case no: ZA-2024-1937-CUB. Zoning: C2-1; Council District 5. Motion: The Greater Wilshire Neighborhood Council

[see the below Motion].

**MOTION** (by Mr. Gresham, seconded by Ms. Harvey): The Greater Wilshire Neighborhood Council supports the requested Conditional Use Permit for the project at 460 S. La Brea Ave., so long as the Permit is subject to the same conditions as set forth in the Conditional Use Permit of the previous operator.

**DISCUSSION**: Mr. Gresham reported that adjacent neighbors supported the application. He said "there's not going to be any entertainment . . . They've had no problems with parking . . . They're not going to be noisy." The owner only was requesting an hours of operation change.

**MOTION PASSED** by a roll call vote of the 15 eligible voters present with eight in favor ("Yes" or "Aye") (Atlee, Carpenter, Carroll, Galan, Gresham, Kim, Sicilia and Smith); seven opposed ("No" or "Nay") (Appel, Chvatal, D'Atri, Harvey, Starr, Trainer and Winther); zero abstained.

- D. Interim Control Ordinance for 100% Affordable Housing: Councilmember Katy Yaroslavsky's proposed ordinance will require that 100% affordable housing projects in HPOZs go through a discretionary review process. Motion: The Greater Wilshire Neighborhood Council supports Councilmember Yaroslavsky's proposed Interim Control Ordinance that requires a discretionary review process for proposed affordable
- Greater Wilshire Neighborhood Council Gen'l Bd Mtg Minutes Jul. 10, 2024 Pg. 10 of 15 housing projects in Historic Preservation Overlay Zones (HPOZs). It is further recommended that affordable housing projects in HPOZs be consistent with the goals, policies, objectives and other applicable requirements of the Historic Preservation Plan in which an affordable housing project is located.

Mr. Gresham said the above Item was moot and not needed.

**MOTION to POSTPONE** to the next Meeting (by Mr. Gresham, seconded by Mr. D'Atri).

**MOTION to POSTPONE PASSED** unanimously by consent; zero opposed; zero abstained.

E. Statewide Preservation: The LA Conservancy signed onto a letter in opposition to Proposed Assembly Bill 2580, alongside the California Preservation Foundation and other preservation groups statewide. They argue that the proposed legislation incorrectly frames historic preservation as a constraint and impediment to housing development. Motion: The Greater Wilshire Neighborhood Council will express its opposition to AB 2580, which, without facts, unduly targets historic preservation as an impediment to the creation of affordable housing, to the Mayor and the Members of the Los Angeles City Council, and will encourage stakeholders within Greater Wilshire to voice their

opposition to the Bill to their State Representatives, particularly to those who represent Greater Wilshire.

Mr. Gresham explained the above. Mr. Starr added that the State says that Neighborhood Councils can't tell Stakeholders to voice their opinions on State matters. It was agreed to replace the Motion word "encourage" with the word "inform" and the wording "to voice their opposition to the Bill to their State Representatives, particularly to those who represent Greater Wilshire" with "how to voice their opinion on the Bill to their State Representatives."

**MOTION** (by Mr. Gresham, seconded by Ms. Chvatal): The Greater Wilshire Neighborhood Council will express its opposition to AB 2580, which, without facts, unduly targets historic preservation as an impediment to the creation of affordable housing, to the Mayor and the Members of the Los Angeles City Council, and will inform stakeholders within Greater Wilshire how to voice their opinion on the Bill to their State Representatives.

**MOTION PASSED** by a roll call vote of the 15 eligible voters present with 12 in favor ("Yes" or "Aye") (Appel, Carpenter, Carroll, Chvatal, D'Atri, Gresham, Harvey, Kim, Sicilia, Smith, Trainer and Winther); two opposed ("No" or "Nay") (Atlee and Galan); one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Starr).
