A. **Discussion of the Safe Clean Water Project and Opportunities to apply for SCWP funds for projects within GWNC:** Vanessa Boudreau spoke to us at our June 12, 2025 meeting about the LA County's Safe Clean Water Program (SCWP), a stormwater infrastructure program, which was funded by LA County Measure W in 2018, with approx \$280M spent annually. She described opportunities for community participation in SCWP and gave some examples of on-going SCWP community projects.

The Westwood Greenway (see <https://westwoodgreenway.org/>) has obtained funds from SCWP to maintain their greenway. Possible speaker from the Westwood Greenway to elaborate on how they applied for funds.

B. **Discussion of Wilshire Country Club golf course upgrade:** Several GWNC residents have contacted GWNC to determine if the Wilshire Country Club will be using herbicides on the new golf course and if they could use more native plants on site. The impact of herbicides on human health is a topic of current research, see the May, 2025 JAMA article "[Proximity to Golf Courses and Risk of Parkinson Disease.](#)" We are communicating with Katie Tilford, Theodore Payne Foundation, to see if she could speak at our next Sustainability Committee meeting.

C. **Community Beautification Day - at the John C Fremont Public Library:** The Hancock Park Garden Club proposal - with input from the GWNC Sustainability Committee - to update the landscape at the John C Fremont Public Library was accepted by the Library. Our input consisted of proposing a butterfly garden in the parking area. We can look for volunteers to help with this project.

VIRTUAL MEETING TELECONFERENCING INSTRUCTIONS / PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS – Every person wishing to address the Board/Committee should dial (669) 900-6833 or (877) 853-5257 and enter 928 2781 1179, then press # to join the meeting.

The GWNC shall make reasonable efforts to accommodate any member of the public that requests an accommodation to participate in the meeting, by providing a publicly accessible physical location for the member of the public to participate from, providing access to technology necessary to participate in the meeting, or identifying locations or resources available that could provide the member of the public with an opportunity to participate in the meeting.

To address the Board on any agenda item before the Board takes action on that item, the public is requested, when prompted by the chairperson, to dial *9 (if connecting by phone) or press the “raise hand” button (if using the Zoom app). Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda but which are within the Board’s jurisdiction will be heard during the General Public Comment period. The Board is prevented from acting on a matter brought to its attention during the General Public Comment period; however, it may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the chairperson.

Public comment cannot be required to be submitted in advance of the meeting. Only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, or if members of the public are unable to provide public comment or be heard due to issues within the Greater Wilshire Neighborhood Council’s control, the meeting must be recessed or adjourned.

SB 411 Updates: In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body’s control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public Comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not

close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
