A. Submission of CIS on Council File 22-1402: (Community and Municipal Greenhouse Gas Emissions Inventory / Carbon Reduction Goals / Climate Impact Team / Capital and Technology Improvement and Expenditure Program (CTIEP))

- i. The Greater Wilshire Neighborhood Council urges the Los Angeles City Council to adopt a policy that proactively limits the use of all non-essential pesticides, including but not limited to glyphosate (Roundup), on all City-owned and managed properties, parks, and facilities. Furthermore, we request that the City explore safer, organic, and nature-based alternatives for landscape management and integrate these policies into the City's broader environmental goals currently being addressed in Council File 22-1402.

This City Council File was determined to not be applicable to our previous meeting on 10/16/2025 and the presentation given that day.

B. Submission of letters to CD5 and CD 13 City Councilmembers requesting meeting regarding the use of pesticides. BACKGROUND: Several GWNC residents have contacted GWNC regarding new reports linking pesticides to Parkinson's and other diseases. GWNC ESC held a meeting and invited a subject matter expert, Dr. Beate Ritz, to speak. We would like to discuss the letter, modify it if needed, and submit the letters to the GWNC Board for their approval at the Board meeting on Wed 10/12.

- i. **Possible Motion:** The GWNC ESC approves the attached letter requesting an opportunity to meet with the CMs and/or their staff members to discuss the topic of pesticide use on City-controlled properties and to review the research the ESC has collected for discussion at the GWNC Board and transmission to the CD 5 and CD 13 City Councilmembers.

The Motion was proposed by Polly Estabrook and seconded by Anders Waalen. All four members present approved the motion (Polly, Anders, Julie Dalton, and Andy Galan).

V. **NEW BUSINESS** (Discussion and Possible Action) These topics were not covered due to lack of time.

introduced a [resolution](#) (in [Council File 25-1295](#)) to oppose the gondola and urge Metro to do the same.

Possible CIS: The GWNC ESC opposes the creation of a gondola to access Dodger Stadium as currently planned and urges Metro to oppose as well. (Sentence can be amplified on in meeting and rationale given.)

The GWNC shall make reasonable efforts to accommodate any member of the public that requests an accommodation to participate in the meeting, by providing a publicly accessible physical location for the member of the public to participate from, providing access to technology necessary to participate in the meeting, or identifying locations or resources available that could provide the member of the public with an opportunity to participate in the meeting.

To address the Board on any agenda item before the Board takes action on that item, the public is requested, when prompted by the chairperson, to dial *9 (if connecting by phone) or press the “raise hand” button (if using the Zoom app). Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda but which are within the Board’s jurisdiction will be heard during the General Public Comment period. The Board is prevented from acting on a matter brought to its attention during the General Public Comment period; however, it may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the chairperson.

Public comment cannot be required to be submitted in advance of the meeting. Only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, or if members of the public are unable to provide public comment or be heard due to issues within the Greater Wilshire Neighborhood Council's control, the meeting must be recessed or adjourned.

SB 411 Updates: In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public Comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
