- A. **200 and 202 S. Orange Drive Synagogue:** The City Planning Department has issued a Letter of Determination (LOD) granting a CUP for this project. A Planning Commission Hearing date is set for June 23, 2026. Citrus Square neighbors have requested that the GWNC review how the conditions in the Planning Department LOD differ from the previous position of the GWNC. It should also be noted that the LOD also includes a provision for the GWNC to host an annual meeting between the synagogue and the neighbors to air differences.
- B. **600 S. La Brea Ave. (& 6th):** (Mike Obogeanu) Filing date: 3/18/25. A CUB to sell a full line of alcohol for on-site consumption in conjunction with a new 5,707 sf restaurant (Meet Me at 6) having 243 total seats (135 indoor/108 outdoor patio). Hours of operation: 8am-midnight, Sun-Thurs; 8am-1am, Fri & Sat; patio: 8am-10pm, daily. Case no: ZA-2025-1630-CUB. Zoning: C2-1. Area 6: La Brea-Hancock; CD 5.

- A. **5750 Melrose Ave. (& Lucerne):** Filing date: 7/3/25. A CUB to allow the sale and dispensing of a full line of alcoholic beverages for onsite consumption in conjunction with an existing 2,422 sf restaurant (Cobi's) with 73 interior seats and 42 exterior seats. Hours of operation: 10:30am-11:00pm, daily. Case no: ZA-2021-9307-CUB. Zoning: C1-1VL. Area 7: Larchmont Village; CD 13.
- B. **810 S. Wilton Pl. (& 8th):** (Ben Borukhim) Filing date: 1/15/26. Demo of an existing SFD and construction of a new 6-story, 16-unit multi-family residential building, with (2) extremely low income (ELI) units and (14) market-rate units, (5) vehicular parking spaces, balconies along the front façade, two recreation rooms, and a rooftop common open space area. Requested TOC (tier 3) incentives include: 1. Height increase (two additional stories / 22 feet) 2. Side yard reduction (30%) 3. Open space reduction (10.7%). Case no: DIR-2026-212-TOC-VHCA. Zoning: R3-1. Area 3: Country Club Heights; CD 5.

- A. **4135 Wilshire Blvd.** (btwn Irving & Bronson): (Gary Benjamin) Filing date: 6/24/25. Construction of a new 98,764 sf, 8-story, mixed-use building with 54 condominium dwelling units, including (11) one-bedroom, (35) two-bedroom, and (8) three-bedroom units, with (3) Very Low Income units (5% of the base density). The project will also include 3,880 sf of retail space, (88) residential parking spaces, (2) commercial parking spaces, and 3,986 sf of open space. Case no: CPC-2025-3538-DB-SPPC-DRB-VHC / VTT-84881. Zoning: CR(PKM)-1. Area 14: Windsor Square; CD 13.

[The Department of Neighborhood Empowerment maintains that this language is required, although it's also possible to address the board or committee using the Zoom app. In other words, it's not true that you "must" dial in. Please see the Zoom instructions below and the link on Page 1 of this agenda.]

The GWNC shall make reasonable efforts to accommodate any member of the public that requests an accommodation to participate in the meeting, by providing a publicly accessible physical location for the member of the public to participate from, providing access to technology necessary to participate in the meeting, or identifying locations or resources available that could provide the member of the public with an opportunity to participate in the meeting.

To address the Board on any agenda item before the Board takes action on that item, the public is requested, when prompted by the chairperson, to dial *9 (if connecting by phone) or press the "raise hand" button (if using the Zoom app). Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda but which are within the Board's jurisdiction will be heard during the General Public Comment period. The Board is prevented from acting on a matter brought to its attention during the General Public Comment period; however, it may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the chairperson.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. **California Government Code Section 54953.8(b)(3).**

The legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. **California Government Code Section 54953.8(b)(4).**

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. **California Government Code Section 54953.8(b)(5).**

A legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to paragraph (5), to provide public comment until that timed public comment period has elapsed. **California Government Code Section 54953.8(b)(6)(A).**

A legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to paragraph (5), or otherwise be recognized for the purpose of providing public comment. **California Government Code Section 54953.8(b)(6)(B).**
