I. WELCOMING REMARKS

- A. Call to order & Flag Salute (Owen Smith President)
 A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held on Wednesday, September 14, 2016, at the Ebell of Los Angeles, 743
 S. Lucerne Blvd., Los Angeles. President Owen Smith called the meeting to order at 7:00 p. m. The Pledge of Allegiance was said.
- B. Roll Call (Joe Hoffman Secretary)

Secretary Joseph Hoffman called the roll. Fifteen of the 21 Board Members or their Alternates were present at the Roll Call: Colette Amin (Alternate for Tucker Carney), Jeffry Carpenter, Patricia Carroll (Treasurer), Michael Genewick, Karen Gilman, John Gresham, Joseph Hoffman (Secretary), Bobbie Kumetz, Frances McFall, Caroline Moser, Owen Smith (President), Julie Stromberg, John Winther, Greg Wittmann and James Wolf (Vice-President). Scott Appel, Charles D'Atri and Nancy Kim arrived later. Philip Farha, Barbara Savage and Steven Senigram were absent and not represented by an Alternate. The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 3/5 of the 21 currently filled Board Seats, or 13 Members (see

VIII. <u>OUTREACH COMMITTEE</u> (Discussion and Possible Board Action as noted) (Joe Hoffman)

A. Update on the August 28, 2016 meeting. Report on the America Red Cross Disaster Preparedness presentation by Julie Thomas. Neighborhood Council Emergency Preparedness Alliance, Yoga in the Park, and continuing efforts to engage our Stakeholders on issues addressed by GWNC and its Committees.

Mr. Hoffman reported that "we had a great meeting"; he noted the above and explained the Larchmont Fair booth procedure.

B. Citizen Recognition Award: Jess Carter (Colette Amin)

Ms. Amin presented the Award to Ms. Carter, who teaches Yoga at Robert Burns Park Saturdays-Thursdays at 10:00 a.m. and Friday at 9:30 a.m. Ms. Carter thanked the Board and encouraged participating.

Alternate Board Member Colette Amin left at this time, making 17 Board Members (or their Alternate(s)) present (the GWNC quorum at this Meeting was 13).

C. Larchmont Fair (Discussion and Possible Board Action). The theme for our booth this year will be Emergency Preparedness. We are partnering with the Red Cross who will provide volunteers and materials to assist us at the fair. **Proposed Motion**: That the GWNC approve a booth at \$350.00 plus a fully refundable \$100.00 clean up deposit for the Larchmont Fair on Sunday, October 30, 2016.

FUNDING MOTION (by Mr. Hoffman, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council approves a booth at \$450.00 which includes a fully refundable \$100.00 clean up deposit for the Larchmont Fair on Sunday, October 30, 2016.

FUNDING MOTION PASSED unanimously by a roll call vote of the 17 eligible voters present with all 17 in favor ("Yes" or "Aye") (Appel, Carpenter, Carroll, D'Atri, Genewick, Gilman, Gresham, Hoffman, Kim, Kumetz, McFall, Moser, Smith, Stromberg, Winther, Wittmann and Wolf); zero opposed; zero abstained.

D. Content of October 2016 GWNC ad in the Larchmont Ledger (Discussion and Possible Board Action). The GWNC purchased 3 ads (1/8 page, 5.9" x 4") in the Larchmont

Ledger with the GWNC's end-of- year surplus funds. The ads must be consecutive. The first ad ran in September 2016. The second GWNC ad will run in October 2016 and options include a general GWNC ad, upcoming events, etc. **Proposed Motion**: That the GWNC approve a topic for the October 2016 Larchmont Ledger ad.

Mr. Hoffman encouraged suggestions for ad content.

IX. <u>TRANSPORTATION COMMITTEE</u> (Discussion and Board Action, as noted) (Julie Stromberg)

A. Report on September 7, 2016 Town Hall Meeting on Highland Ave. (Olympic Blvd. to Melrose Ave.) Traffic. The GWNC hosted a Town Hall Meeting on September 7, 2016, at

The Ebell of Los Angeles to discuss traffic issues on Highland Ave. from Olympic Blvd. to Melrose Ave. and possible related mitigations. The Town Hall featured Councilman David Ryu (Los Angeles City Council District 4) and a panel with representatives from Los Angeles Police Department West Traffic Division, Los Angeles Department of Transportation, Los Angeles City Council District 4, and Los Angeles City Council District 5.

Ms. Stromberg noted the above and that Sycamore Square and south of Olympic representatives attended, and that the DOT "has committed to do a survey on Highland Avenue in the next 90 days."

B. Next Transportation Committee Meeting: Monday, October 3, 2016, 7:00 p.m.; Marlborough School, 250 S. Rossmore Ave., 90004.

Ms. Stromberg noted the above.

X. <u>SUSTAINABILITY COMMITTEE</u> (Julie Stromberg, Barbara Savage)

A. Report on September 13, 2016 Sustainability Committee Meeting. Meeting featured a presentation: "Climate Change and LA: What it is, and what LA can and should do about it." (Dan Kegel; B.S. '86, Caltech) Mr. Kegel provided a primer on Climate Change with a specific discussion on what Angelenos can do to make an impact. Meeting included a discussion on the Committee's Parkway Challenge, LA City Council vote regarding move toward 100% clean energy, and upcoming Committee programs.

Ms. Stromberg reported that "it was a really invigorating discussion, an excellent presentation."

B. Next Sustainability meeting: December 13, 2016, time and location TBD.

Ms. Stromberg noted the above.

XI. <u>NEW BUSINESS</u> (matters not previously identified for future consideration and action) A. The Clean Streets Program (Owen Smith)

Mr. Smith reported about the proposed Peru Village and cautioned about email content.

XII. LAND USE COMMITTEE (Jim Wolf) (Discussion and Board Action, as noted)
 A. 117 N. Manhattan Place. 8-unit SLS, 10K square feet, 15-foot front setback, 5-foot side and rear setbacks. Applicant has appeared before the LUC on three occasions. Continuing concerns of the LUC and neighbors include the height, presentation to the street, and architectural style relative to neighboring buildings. Hearing on the Vesting Tentative Tract map scheduled for September 14, 2016. ENV- 2015-3922-EAF, VTT-73902-SL. Committee voted 6-0 with 2 abstentions to oppose the project as presented. Proposed Motion: That the Greater Wilshire Neighborhood Council [see the below Motion].

MOTION (by Mr. Smith, seconded by Mr. Wolf): The Greater Wilshire Neighborhood Council opposes the application for a Vesting Tentative Tract Map for the project at 117 N. Manhattan Pl.

MOTION PASSED unanimously by a hand vote.

B. 520 N. La Brea Ave (Lyric Theater) Application for a CUB for the sale and dispensing of a full line of alcoholic beverages for on-site consumption and a CUX to allow patron dancing all in conjunction with the change of use of a 3516 SF adult school to a proposed new theater with live entertainment consisting of bands, DJs, comedy shows, theater performances. Proposed hours of operation are 10am to 2am daily. Lyric Theatre. Applicant has appeared before the LUC three times and provided the requested follow-up outreach to neighbors regarding potential noise issues. Committee voted unanimously to support the application. **Proposed Motion**: That the Greater Wilshire Neighborhood Council [see the below Motion].

MOTION (by Mr. Wolf, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council supports the CUB application for the sale and dispensing of a full line of alcoholic beverages for on-site consumption and CUX application to allow patron dancing for a proposed new theater with live entertainment consisting of bands, DJs, comedy shows, theater performances with proposed hours of operation from 10am to 2am daily, including the voluntary conditions presented by the applicant for 520 N. La Brea Ave.

DISCUSSION: Representative Kyoshi Graves explained the Application and said "we'll stop alcohol sales at 1:30." Mr. Hoffman explained the conditions and that the Committee unanimously supported the Application. Ms. Moser added that the neighbors supported it.

MOTION PASSED by a hand vote with 14 in favor; three opposed; zero abstained.

C. 703 N. McCadden (vacant lot) Application to subdivide into two lots and build a Duplex on each lot in an R2-1XL zone. ENV- 2016-1964-CE, AA-2016-1963-PMLA. Applicant returned to the LUC to show design changes made per requests by the Committee and the South Hollywood Neighborhood Association (SHNA). Don Hunt, President, SHNA, reported that the SHNA unanimously supported the project. Committee voted unanimously to support the application. Note that since the applicant's hearing was on 9/7/16 the LUC sent a letter to Planning indicating the LUC's recommendation prior to a Board vote. **Proposed Motion**: That the GWNC [see the below Motion].

MOTION (by Mr. Wolf, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council supports the application to subdivide into two lots and build a duplex on each lot in an R2-1XL zone for 703 N. McCadden Place.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

- D. Larchmont Heights Neighborhood Conservation Ordinance, La Brea-Hancock Neighborhood Conservation Ordinance Code amendments to add 12 new single family zones to the zoning code and zone changes for neighborhood conservation ICO areas. The proposed new single family zones for the South Hollywood, Larchmont Heights, and La Brea-Hancock neighborhoods would involve a zone change from R 1-1 (BMO) to R1 R2-RG, a proposed new zone, which regulates the location of a new second story to be located toward the rear of the building, requires new garages to be detached and located at the rear of the property, and a floor area of between 35% and 45% of the lot, depending on lot size. These proposed new single-family zones will supersede the existing R1 (or BMO) regulations. CPC-2016-2112-ZC, CPC-2016-2112-ZC. Hearing date: 10/13/2016.
- E. Second Dwelling Unit Ordinance. The LA City Council scheduled a September 13th vote on an Ordinance relative to granting legal nonconforming status to second dwelling units, for the purpose of complying with State law AB 1866. Council File: 14-0057-S8.

Homeowner Ira Belgrade explained that he has a 1,200 square foot second dwelling unit. Mr. Wolf agreed to Agendize this for the Committee.

 - vi. 7000-7024 W. Melrose Ave Density bonus with on-menu incentives for a 40- unit, 2story residential development.
