

Greater Wilshire Neighborhood Council General Board Meeting July 12, 2017 Approved by the Board on September 13, 2017

I. <u>WELCOMING REMARKS</u> (Owen Smith)

- A. Call to order (Owen Smith President)
 A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held on Wednesday, July 12, 2017, at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles. President Owen Smith called the meeting to order at 7:04 p. m.
- B. Flag Salute (Frances McFall) The Pledge of Allegiance was said.
- C. Roll Call (Joe Hoffman Secretary)

Secretary Joseph Hoffman called the roll. Sixteen of the 21 Board Members or their Alternates were present at the Roll Call: Tucker Carney, Jeffry Carpenter, Patricia Carroll (Treasurer), Charles D'Atri, Karen Gilman, John Gresham, Joseph Hoffman (Secretary), Sue Horwitz (Alternate for Steven Senigram), Max Kirkham, Bobbie Kumetz, Barbara Savage, Angie Szentgyorgyi (Alternate for Caroline Moser), Owen Smith (President), Julie Stromberg, John Winther and Greg Wittmann. Five Board Members were absent and not represented by an Alternate: Scott Appel, Philip Farha, Michael Genewick, Frances McFall and James Wolf (Vice-President). The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 3/5 of the 21 currently filled Board Seats, or 13 Members (see

https://lacity.quickbase.com/db/bj3apxsp3?a=q&qid=32&qskip=0&qrppg=1000&dlta=su46 ~), so the Board could take such votes. All 21 of the 21 Board Seats were filled (by election or appointment). Four Alternate Seats were vacant [Education; Religion; Area 3; and Area 9; to apply see www.GWNC.org.] Also attended: approximately 15 Stakeholders and guests.

Ms. Stromberg read aloud the below Motion.

MOTION (by Ms. Stromberg, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council supports the following:

- Whereas the DWP Board of Water and Power Commissions approved the new labor agreement between the Department of Water and Power and IBEW Local 18 at a Special Meeting on Tuesday, June 20, 2017;
- Whereas the Notice of this Special Meeting was not given until Monday, June 19, 2017;

Whereas the documentation concerning the new labor agreement was not placed on line until the day of the meeting;

Whereas the City Council approved the new labor agreement on June 28, 2017;

- Whereas DWP, the City Council, and the Mayor did not conduct any outreach to the Neighborhood Councils or the Ratepayers;
- Whereas, the lack of transparency erodes the trust of confidence of Ratepayers and Angelenos in the Department, the City Council, and the Mayor;
- Therefore, the DWP Committee condemns the lack of transparency by DWP, the City Council, and the Mayor;
- Therefore, the Greater Wilshire Neighborhood Council calls for a full presentation and discussion on the new labor agreement to the Neighborhood Councils and Ratepayers.

MOTION PASSED unanimously by a hand vote with all 16 in favor; zero opposed; zero abstained.

FUNDING MOTION PASSED unanimously by a roll call vote of the 16 eligible voters present with all 16 in favor ("Yes" or "Aye") (Carney, Carpenter, Carroll, D'Atri, Gilman, Gresham, Horwitz, Hoffman, Kirkham, Kumetz, Savage, Smith, Stromberg, Szentgyorgyi, Winther and Wittmann); zero opposed; zero abstained.

- E. Review and update of General Treasury information and DONE update. Ms. Carroll reported that all NC's financial information will be posted online.
- F. Budget Package for FY 2017-2018 (Discussion and board action) (Carroll/Hoffman). DONE budget package for FY 2017-2018 includes the Annual Budget, Outreach Survey, Self-Assessment, and Strategic Plan.

Copies were distributed of a completed "Outreach Survey #39"; "Self-Assessment Form #27"; "Strategic Plan #53"; "FY 2017-18 Draft Budget"; "FY 2017-18 Budget Calculations Worksheet"; and "UnionBank Statement of Accounts . . . 05/01/17 – 06/30/17." Ms. Carroll reviewed the Worksheet and Draft Budget, reminding that the Budget is adjustable. It was noted that the proposed monthly allocation for Line J "ADV-Larchmont Chronicle, FB, etc." should be \$340, not "\$3,400"; and that note #3 should be "A minimum of mailings would discount the Mailchimp cost." There was very extensive discussion regarding Board Members' workload, time available, responsibilities and work performed; DONE's expectations and requirements; Greater Wilshire-area community service history and needs; and visions and beliefs of the GWNC's role and responsibilities.

FUNDING MOTION (by Mr. Hoffman, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council accepts its FY 2017-18 Draft Budget with the following revisions: Line E "Contract Services – Admin consultant" to be revised downward from \$19,980 to \$16,000 and Line L "ADV-Sponsorship and events" to be revised upward from \$1,000 to \$1,577.

FUNDING MOTION PASSED by a roll call vote of the 16 eligible voters present with 12 in favor ("Yes" or "Aye") (Carney, D'Atri, Horwitz, Hoffman, Kirkham, Kumetz, Savage, Smith, Stromberg, Szentgyorgyi, Winther and Wittmann); four opposed ("No" or "Nay") (Carpenter, Carroll, Gilman and Gresham); zero abstained.

Mr. Hoffman explained and there was extensive discussion of Strategic Plan elements.

Board Member John Gresham left at this time (9:15), making 15 Board Members (or their Alternate(s)) present (the GWNC quorum at this Meeting was 13).

MOTION (by Mr. D'Atri, seconded by Mr. Hoffman: The Greater Wilshire Neighborhood Council accepts its 2017-2018 Strategic Plan with the following change: in "The BIG Goals . . . 2)" delete the phrase "Remain an "island of enforcement""; and accepts its Self-Assessment Form and Outreach Survey.

The President did not vote. [Presiding Officers can choose whether or not to vote; if they don't a vote can still be unanimous.]

A. 985-991 3rd Ave, formerly 3607 W. Olympic Blvd. (Discussion and Possible Action) (Laszlo Faerstain) Applicant requests a Vesting Tentative Tract for 6 single- family lots in accordance with the Small Lot Subdivision Ordinance No. 176,354 on a 7,982.3 square foot parcel of land in the C2.1 zone. Applicant attended the Jan. 2016 Meeting but did not present and has since completely revised the project the developer did not appear. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council oppose the project at 985-991 3rd Ave until presented by the applicant.

B. 4806 W. Elmwood Ave (Discussion and Possible Action) (T. Kim) Demolish 1 existing single family dwelling, construct 4 lots small lot subdivision AA-2017-1576-PMLA, ENV-2017-1577-EAF. The Land Use Committee voted 9, 0, 0 to oppose the project the developer did not appear. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council oppose the project at 4806 W. Elmwood until presented by the applicant.

MOTION (by Mr. Hoffman, seconded by Ms. Savage): The Greater Wilshire Neighborhood Council opposes the project at 4806 W. Elmwood until presented by the applicant.

MOTION PASSED by a hand vote; zero opposed; zero abstained.

C. 310 S. Van Ness Ave Discussion and Possible action) (Steve Shaw) Renovation of existing rectory interior with second floor addition of 1,007 sq. ft. ZA-2017-0109-PAD, ENV-2017-0110-CE. The Land Use Committee voted 9, 0, 0 to support the project. Proposed motion: That the Board of the Greater Neighborhood Council support the project at 310 S. Van Ness Ave.

MOTION (by Mr. Hoffman, seconded by Ms. Savage): The Greater Wilshire Neighborhood Council supports the project at 310 S. Van Ness Ave.

MOTION PASSED by a hand vote; zero opposed; zero abstained.

D. 5570 Melrose Ave/647 N, Beachwood Ave (Wilshire Discussion and Possible Action) (Tracey Clarke). This project was supported by LUC and the Board. Neighbors have filed an appeal because the developers have not complied with the agreed upon conditions of the DB and would like GWNC support. CPC-2016-4316-DB, ENV-2016-4317-EAF. The Land Use Committee voted 8 yes, 1abs, 0 no to support the neighbor's appeal. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council support the appeal.

Copies were distributed of "Additions and Corrections to the July 12, 2017 Agenda," which stated that "an incorrect motion that did not receive a second was inserted into the agenda. The actual motion based on the one unanimously approved by the Land Use Committee reads as follows: "That the Board of the Greater Wilshire Neighborhood Council request that the development team for 5570 Melrose Ave./647 N, (sic) Beachwood Ave. provide a copy of memorialized items, drawings approved by the Planning Commission, and the

Master Land Use Application to fulfill requests of neighbors and the City Council to the GWNC.""

MOTION (by Mr. Hoffman, seconded by Ms. Gilman): The Greater Wilshire Neighborhood Council requests that the development team for 5570 Melrose Ave./647 N, (sic) Beachwood Ave. provide a copy of memorialized items, drawings approved by the Planning Commission, and the Master Land Use Application to fulfill requests of neighbors and the City Council to the GWNC.

DISCUSSION: Olivia Joncich said "we were unaware that this item was going to be on the Agenda tonight"; she offered to bring revisions to the next meeting. Resident Tracey Clarke, an Appellant, maintained that the developers are not providing enough low-income units, saying "neighbors have issues, especially with traffic . . . parking . . . we weren't notified properly." She believed that half of project support signatures were "from people outside of the Greater Wilshire area." She also was concerned about the project's height; "the rooftop deck . . . in essence makes it six stories . . . the height is 56 feet."

MOTION PASSED by a hand vote with 10 in favor; two opposed; one abstained.

E. 4749 W. Elmwood Ave (Discussion and Possible Action) (Matthew Hayden). Demolition of an existing single family dwelling and construction, use, and maintenance of new 14-unit apartment building, including 1 unit (10%) for very low income households, approximately 45-feet. Pursuant to: LAMC 12.22 a 25, approval of affordable housing incentives for DB as follows: parking option # 1; off-menu incentive-12-foot front yard; off-menu incentive-1 compact stall in lieu of a standard stall. CPC-2017-2121-DB, ENV-2017-2122- EAF. The Land Use Committee voted 9, 0, 0 to oppose the project the developer did not appear. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council oppose the project 4749 W. Elmwood Ave. until presented by the applicant.

MOTION (by Mr. Hoffman, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council opposes the project 4749 W. Elmwood Ave. until presented by the applicant.

MOTION PASSED by a hand vote; zero opposed; zero abstained.

F. Council File #17-0274 Affordable Housing Linkage Fee / Housing Impact Trust Fund / Code Amendment(s) Directing Fees Derived from Projects. The proposed ordinance introduces new regulations to establish the Affordable Housing Linkage Fee, a fee levied on new development meeting specific criteria to mitigate that development's impact on the demand for affordable housing. Fees generated as a result of this ordinance may be used to fund the construction of new units, or for the rehabilitation and preservation of existing affordable units.. The Land Use Committee voted 6, 2, 0 to oppose the Proposed Ordinance. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council oppose the Proposed Affordable Housing Linkage Fee Ordinance.

Copies were distributed of an "Ordinance Background" and "Additions and Corrections to the July 12, 2017 Agenda," which stated a "Proposed Board Resolution: Be it resolved that

the Greater Wilshire Neighborhood Council opposes the proposed Affordable Housing Linkage Fee. The current costs to build new units once parking requirements, Quimby and other fees are factored in, are already high and contribute to the high rental rates/prices of most of the new units that enter the housing market. The proposed addition of a \$12 per sq. ft. fee for residential construction over 5 units, with only modest exceptions for the inclusion of affordable units, could have the unintended consequence of either stifling the development of new housing stock or of further driving up prices on that new stock. With a deficit of over 400,000 unit in current housing stock in Los Angeles and rising prices, the LA City Council should be considering methods of reducing building costs where appropriate so that the construction of more affordable housing is possible, not raising more cost barriers." Mr. Hoffman explained the issue and Committee position.

MOTION (by Mr. Hoffman, seconded by Mr. Winther): The Greater Wilshire Neighborhood Council opposes the Proposed Affordable Housing Linkage Fee Ordinance.

MOTION PASSED by a hand vote with nine in favor; two opposed; two abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes).
