# I. WELCOMING REMARKS

A. Call to order (Owen Smith – President)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held on Wednesday, October 4, 2017, at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles. President Owen Smith called the meeting to order at 7:04 p. m.

Secretary Joseph Hoffman called the roll. Fourteen of the 21 Board Members or their Alternates were present at the Roll Call: Colette Amin (Alternate for Tucker Carney), Jeffry Carpenter, Patricia Carroll (Treasurer), Charles D'Atri, Philip Farha, Phivan Ha (Alternate for Karen Gilman), Joseph Hoffman (Secretary), Max Kirkham, Bobbie Kumetz, Frances McFall, Owen Smith (President), Angie Szentgyorgyi (Alternate for Caroline Moser), John Winther and Greg Wittmann. Michael Genewick and Barbara Savage arrived later. Five Board Members were absent and not represented by an Alternate: Scott Appel, John Gresham, Steven Senigram, Julie Stromberg and James Wolf (Vice-President). The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 3/5 of the 21 currently filled Board Seats, or 13 Members (see the Bylaws at

Neighborhood Council Leadership Positions (Discussion and Possible Action) (Julie Stromberg) An issue has arisen with respect to leadership positions in neighborhood council umbrella groups, such as the Neighborhood Council Sustainability Alliance and Budget Advocates, and whether the members of this group in leadership positions should be elected or formerly elected neighborhood council representatives.

Stakeholder Bill Funderburk said that "some of the alliances do not have officers who are accountable" to Neighborhood Councils. Ms. Savage explained that some alliance officers "are non-elected . . . we take ethics classes . . . it can be confusing to people who don't know." She requested Agendizing the GWNC to consider leaving the Neighborhood Councils Sustainability Alliance "until they change their rules."

B. GWNC Neighborhood Purposes Grant Committee (Discussion, Planning, and Possible Action) (Julie Stromberg) GWNC planned on doing a round of Neighborhood Purposes Grant (NPG) awards for two grants up to \$1,000 each before December 2017. Update on status of NPG Committee and this round of NPG awards. This Item was TABLED.

## XII. LAND USE COMMITTEE

- A. 4749 W. Elmwood Ave. (Discussion and Possible Action). Demolition of an existing single-family dwelling and construction, use, and maintenance of new 14-unit apartment building, including 1 unit (10%) for very low-income households, approximately 45-feet. Pursuant to: LAMC 12.22 a 25, approval of affordable housing incentives for DB as follows: parking option # 1; off-menu incentive-12-foot front yard; off-menu incentive-1 compact stall in lieu of a standard stall. CPC-2017-2121-DB, ENV-2017-2122-EAF. The Land Use Committee voted 9, 0, 0 to recommend that the Board oppose the project. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

**MOTION** (by Mr. Farha, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council opposes the project at 4749 W. Elmwood Ave. until applicant returns with additional information requested by the committee.

**MOTION PASSED**; 15 in favor; zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Smith).

B. 5226 W. Melrose Avenue (Discussion and Possible Action). Zone Variance to allow a 370-sq. ft. spray booth within an existing auto body repair facility in the C2 zone. Present use Auto Body Shop with a Spray Booth. Proposed use, (No Change) Auto Body Shop with a Spray Booth. ZA-2017-2354-ZV, ENV-2017-2355-EAF. The Land Use Committee voted 9, 0, 0 to recommend that the Board support the project Proposed motion: That the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

**MOTION** (by Mr. Farha, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council support the Zone Variance to allow a 370-sq. ft. spray booth within an existing auto body repair facility for 5226 W. Melrose Avenue.

**MOTION PASSED**; 15 in favor; zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Smith).

C. 5212 W. Melrose Ave Avenue (Discussion and Possible Action). Repurposing of 10,045 sq ft building for a new boutique hotel use, consisting of up to 18 guest rooms, with a small hotel lobby. Requested entitlements: 1. Conditional use permit to allow a hotel within 500 feet of any A or RE zone; 2. Zone variance to allow the maintenance of the existing driveway width of 8' 9" feet to serve the hotel use in lieu of the required 10 feet; 3. A zoning administrator adjustment to allow parking stackers within the required rear yard setback. ZA-2017-3165-CU-ZVZAA, ENV-2017-3166-EAF. The Land Use Committee voted 9, 0, 0 to recommend that the Board oppose the project. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

**MOTION** (by Mr. Farha, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council oppose the project at 5212 W. Melrose Ave. as presented until additional information can be submitted by the applicant and stakeholders.

**MOTION PASSED**; 15 in favor; zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Smith).

D. 5162-5168 Melrose Ave:(Discussion and Possible Action). Expansion of existing restaurant into the proposed front and rear enclosed patio space with a total 196 seats. The Operation hours 10AM-2AM. Request: Deviation from the hours of operation of the Commercial Corner. Requesting the continued approval hours of operation from 10AM-2AM daily for the restaurant use. Historic Bar, Inc. DBA, The Edmon. ZA-2017-3029-CUB, ENV-2017-3030-CE. The Land Use Committee voted 9, 0, 0 to recommend that the Board support the project. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

**MOTION** (by Mr. Farha, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council support the expansion of the existing restaurant into the proposed front and rear enclosed patio space with a total 196 seats and the continued approval of hours of operation from 10AM-2AM daily for the restaurant use at 5162-5168 Melrose Ave.

**DISCUSSION**: Co-owner Ms. Mailian explained that the hours would be the same for the expansion areas, including outdoors.

**MOTION PASSED**; 14 in favor;zero opposed; two abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (D'Atri and Smith.

E. 250 N. Wilton Place: (Discussion and Possible Action). Applicant proposes to create new 5-small lots for single family residential purposes. Each residence will have its own attached garage. VTT-77081-SL, ENV-2017-3703-EAF. The Land Use Committee voted 9, 0, 0 to recommend that the Board oppose the project. Proposed motion: That the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

**MOTION** (by Mr. Farha, seconded by Mr. Kirkham): The Greater Wilshire Neighborhood Council oppose the project 250 N. Wilton Place. until presented by the applicant.

**MOTION PASSED**; 15 in favor; zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Smith).

F. 5201 Beverly Blvd: (Discussion and Possible Action). Renewal for sales of beer and wine – type 41 ABC license. Chipotle Mexican Grill, Inc. Application for a Plan Approval for on-site sales of beer and wine to serve alongside meals at an existing restaurant with 84 seats – 54 indoor and 32 outdoor on an outdoor patio area. ZA-2013-481-CUB-PAI, ENV-2017-3297-CE. The Land Use Committee voted 9, 0, 0 to recommend that the Board support the renewal with the condition that the license be reviewed if there is a change of operator. Proposed Motion: The Greater Wilshire Neighborhood Council [see the below Motion].

**MOTION** (by Mr. Farha, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council support the renewal of the Plan Approval for on-site sales of beer and wine for the restaurant at 5201 Beverly Blvd. with the condition that any change of operator trigger a review of the CUB.

**MOTION PASSED**; 15 in favor; zero opposed; one abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes) (Smith).
