

Greater Wilshire Neighborhood Council General Board Meeting May 9, 2018 Approved by the Board on June 13, 2018

I. WELCOMING REMARKS

A. Call to order (Owen Smith – President)

A duly noticed Meeting of the Greater Wilshire Neighborhood Council ("GWNC") Board of Directors was held on Wednesday, May 9, 2018, at the Ebell of Los Angeles, 743 S. Lucerne Blvd., Los Angeles, CA 90005. President Smith called the meeting to order at 7:30 p. m.

- C. Roll Call (Joe Hoffman Secretary)

The Secretary called the roll. Nineteen of the 21 Board Members or their Alternates were present at the Roll Call: Scott Appel, Tucker Carney, Jeffry Carpenter, Patricia Carroll (Treasurer), Philip Farha, Michael Genewick, Karen Gilman, John Gresham, Joseph Hoffman (Secretary), Bradley Jewett, Max Kirkham, Bobbie Kumetz, Frances McFall, Nathalie Rosen (Alternate for Julie Stromberg), Steven Senigram, Angie Szentgyorgyi (Alternate for Caroline Moser), Owen Smith (President), John Winther and Greg Wittmann. Charles D'Atri arrived later. James Wolf (Vice-President) was absent and not represented by an Alternate. The GWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 3/5 of the 21 filled Seats, or 13 Members (see the Bylaws at

- XII. <u>NEW BUSINESS</u> (matters not previously identified for future consideration and action)
 - A. Sober Living Homes and Detox Centers (Discussion and Possible Action) (Judy Han-Gregory and Michael Stokes). Recommendation to support the motion by Councilmember Koretz (CF #17-1426) to review mitigation of impacts of all kinds of group homes via a Community Impact Statement. Proposed Motion: The Board of the Greater Wilshire Neighborhood Council [see the below Motion].

Copies were distributed of a City Council Motion, and letters from Brad Kane, President, South Carthay Neighborhood Association, and from Marqui Hood, President, Wilshire

MOTION (by Mr. Kirkham, seconded by Mr. Gresham): The Greater Wilshire Neighborhood Council supports the motion of Councilmember Koretz dated December 13, 2017, instructing the City Attorney and Chief Legislative Analyst to review the legislative and regulatory opportunities the City may have for mitigating the impacts of all kinds of group homes on surrounding neighborhoods and communities, including a thorough review of such efforts undertaken in other jurisdictions, and to report back to the City Council with analysis, options and recommendations.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

- **XIII.** <u>LAND USE COMMITTEE</u> (Discussion and Possible Action) (Caroline Labiner-Moser) [*The following sub-section first paragraphs are copied from the Agenda.*]
 - A. 326 S. Larchmont Blvd. The Jane Club: (Discussion and Possible Action) (John Rissier) Jane Club, a business, attempting to open at 326 S. Larchmont. Blvd. Issue is commercial use of a property in the R1-1 zone.

It was noted that the project address is 236 S. Larchmont, not "326." Copies were distributed of a Larchmont Buzz article. Resident John Rissier said "it's a business opening right behind my house." Mr. Hoffman noted that the owner currently is not attempting to open. Mr. D'Atri relayed that CD4 reported to the Larchmont Village Neighborhood Association that the operators thought the neighbors would support the business. Ms. Gilman said that "they're seeking another location." No Motion was made or vote taken.

B. 4827 W. Oakwood Ave: (Discussion and Possible Action) (Kenneth Ree, King Woods). Preliminary Parcel Map for a Small Lot Subdivision. Demo a Single-Family Residence to construct a 4-unit SLS. AA-2017-5342-PMLA-SL, ENV-2017-5343-CE. The applicants provided the documentation on their outreach and The LUC voted to support the project. Proposed Motion: The LUC recommends that the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

Copies were distributed of project information and a signed petition.

MOTION (by Mr. Kirkham, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council supports the Preliminary Parcel Map for a Small Lot Subdivision at 4827 W. Oakwood Ave.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

Board Member John Gresham left at this time (8:39), making 19 Board Members (or their Alternate(s)) present (the GWNC quorum at this Meeting was 13).

C. 4817 W. Elmwood Ave: (Discussion and Possible Action) (Jack Moses) Construction of 2 new duplex buildings, each with an enclosed 2 car garage. The front building will be set back 15-feet in lieu of the required 30- foot setback established through building line ordinance # 46358, to allow a driveway for the 4 garages. ZA-2018-1173-ZAA, ENV-2018-1174- CE. The Committee voted to support the project. Proposed Motion: The LUC recommends that the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

MOTION (by Mr. Kirkham, seconded by Mr. Hoffman): The Greater Wilshire Neighborhood Council supports the proposed 15-foot front yard setback in lieu of the required 30 foot setback at 4817 W. Elmwood Ave.

MOTION PASSED by a hand vote with 17 in favor; zero opposed; two abstained (the GWNC counts abstentions as neither "yes" votes or "no" votes).

D. 4653, 4653 ½, 4655, 4657 Beverly Blvd: (Discussion and Possible Action) (Tari Kuvhenguhwa, Eddie Navarrette). A CUB to allow the Zone Change for the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing 2,322 sq. ft. restaurant with 48 indoor seats and with hours of operation from 8:00 am to 1:00 am daily. ZA-2018-1943 CUB, ENV- 2018-1944-CE. The Committee voted to oppose the project because the presenters did not appear. Proposed Motion: The LUC recommends that the Board of the Greater Wilshire Neighborhood Council [see the below Motion].

MOTION (by Mr. Kirkham, seconded by Mr. D'Atri): The Greater Wilshire Neighborhood Council opposes the application at 4653, 4653 ½, 4655, 4657 Beverly Blvd. until presented by the applicant.

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

E. Brookside Proposed Zone Change: (Discussion and Possible Action) (Samantha Karim and Jan Wieringa) Lengthy neighborhood discussion on the pros and cons of the R1-V3-RG vs the R1-R3-RG or the split version proposals. After failing to support the single R1-V3-RG zone on a tie vote, the committee voted to support the two variation zones, as recommended by the Planning Commission, by a narrow margin. Proposed Motion: The LUC recommends that the Board of the Greater Wilshire Neighborhood Council support the two separate R1 variation zones for Brookside.

Copies were distributed of an article from the "Morning Buzz for Thursday, May 03, 2018"; a letter from resident Jan Wieringa; a map and chart of the area; and a list of "Brookside in Numbers." Mr. Smith said that "no matter how this . . . goes, it has no effect on me" and believed that the R3 zone would restrict families' ability to expand their homes. He explained the relationship between the Brookside community and the GWNC. Mr. Kirkham reviewed Land Use Committee considerations. Mr. Farha said "it's about two different . . . zones . . . one zone is . . . more flexible . . . the square footage is the same on both of them . . . they both have rear garage requirements." Ms. Howard said regarding CD4 that "we have no strong stance." Mr. Hoffman reported that at this Meeting there

were 16 public comment cards supporting the split zoning and nine cards supporting the single zone.

Stakeholders who spoke in favor of having a single R1-V3-RG zone included Brookside Homeowners Association (HOA) Board Member Dana Peterson; Jason and Lisa Boswell; Rosanne Krikorian; Navine Karim; Shirley Capata; Katherine Lewis; Heather MacPherson; Sandi Toll Sepenuk; Matthew Lesher; Bailey Chin; Brent Gold; Samantha Karim, who said there were 218 affected homes and presented 104 supporting petition signatures.

Stakeholders who spoke in favor of having split R1-V3-RG and R1-R3-RG zoning included Randy Haberkamp; J. T. Steiny; Laura Nussbaum; Taylor Louden; Josh Salazar; Daniela Prowizar; Anthony Sands; Roxanne Steiny; Maryellen Keirchen; Hanna Mintz; Jan Wieringa; Paul Nussbaum; Luke Trestor; Steven Schmidt; Laura Cohen; and Amanda Burton. A Stakeholder in favor of split zoning also said there were 104 supporting petition signatures.

Mr. Farha said "the City never did a proper survey." Ms. Howard explained that CD4 was working on the issue.

MOTION (by Mr. Genewick): The Greater Wilshire Neighborhood Council supports two separate R1 variation zones for Brookside.

MOTION FAILED for lack of a second.

Mr. Carney did not believe that the City handled the process well.

MOTION (by Mr. Farha, seconded by Mr. Carney): The Greater Wilshire Neighborhood Council supports a single R1-V3-RG zone in the single-family zone area of Brookside.

DISCUSSION: Mr. Hoffman, Mr. Farha and Mr. D'Atri explained the zoning designations.

Board Member Mike Genewick left at this time (9:40), making 18 Board Members (or their Alternate(s)) present (the GWNC quorum at this Meeting was 13).

MOTION PASSED unanimously by a hand vote; zero opposed; zero abstained.

Mr. Kirkham urged everyone to stay involved with the GWNC and the Land Use Committee.

F. The next Land Use Committee meeting will be May 22, 2018 at Marlborough School, 250 S. Rossmore Ave, the Collins Room, 200-D, Los Angeles, CA 90004. Mr. Hoffman noted the above.
