

#### Greater Wilshire Neighborhood Council Environmental & Sustainability Committee September 13, 2016 Approved by the Committee on March 14, 2017

# 1. WELCOMING REMARKS:

### A. Call to order

A duly noticed meeting of the Environmental & Sustainability Committee of the Greater Wilshire Neighborhood Council ("GWNC") was held on Tuesday, September 13, 2016, at Los Angeles Tennis Club Café, 5851 Clinton St., Los Angeles, CA. Chairwoman Julie Stromberg called the meeting to order at 7:17 p.m.

### B. Roll Call

Two of the four Committee Members were present at the Roll Call: Cathy Roberts and Julie Stromberg. William Funderburk arrived later. Barbara Savage was absent. The GWNC Environmental & Sustainability Committee quorum (the minimum number of Committee Members needing to be present to take binding votes on Agendized Items) is three, so at this time the Committee could only take public comments and could not have any official discussions, and could not make any Motions or take any votes. Four Committee Seats were filled (by election or appointment). ### 4. PRESENTATIONS

A. Climate Change and LA: What it is, and what LA can and should do about it. (Dan Kegel; B.S. '86, Caltech) Mr. Kegel will provide a primer on Climate Change with a specific discussion on what Angelenos can do to make an impact.

Mr. Kegel (https://docs.google.com/presentation/d/1HY\_dM7N4XAC-ODLYXZ05YdeYQa7p5dLhg5t4Y7Mtego/edit#slide=id.g1650dcb0b6\_0\_48) showed slides and presented. The "first estimate of global warming" was in 1896. Scientists noted by 1955 that the Earth's carbon dioxide was increasing. In 1988 the U.S. Senate warned about global warning. August 2016 "was the hottest August in 136 years of modern record-keeping" in the world. He explained the accelerating number of "extreme heat" days. Human-made factors such as pollution and structures can trap and increase heat. Solutions include planting trees; white roofs (they reflect heat); fulfilling the City's goal to reduce its urban temperature; cutting greenhouse gas emissions (efficient equipment and materials such as LED lights can reduce power usage); electrification (such as of vehicles); renewable energy (such as solar panels and/or sign up for the DWP's Green Power Program [https://www.ladwp.com/ladwp/faces/ladwp/commercial/cgogreen/c-gg-

He noted City and State legislative action already taken. There was discussion of car-buying trends.

Committee Member Bill Funderburk arrived at this time (8:21), making a quorum of three Members present. Now the Committee could take binding votes on Agendized Items.

There was discussion of what individuals, organizations and government have done and can do. Mr. Funderburk noted that "demand management" helped reduce power usage during recent heat waves. Stakeholder John Kaliski noted that land use policies have not evolved as fast as technologies. There was extensive discussion about political realities affecting programs, costs and impacts, and technical and political solutions. Ms. Roberts announced an October 5<sup>th</sup>-7<sup>th</sup> GreenBuild Conference [https://greenbuildexpo.com] at the L.A. Convention Center.

A. Discussion, Planning, and Possible Motion on GWNC Environmental & Sustainability Committee-California Greenworks, Inc. Parkway Challenge (Julie Stromberg). Discussion of launch of Parkway Challenge program and key features in the program's pilot sustainable and resilient parkway. In partnership with California Greenworks, Inc., the GWNC Sustainability Committee is devising an outreach program to educate stakeholders on the proper care of trees in parkways with emphasis on the importance of sustainable landscaping. The program will include a "pilot" residential parkway remodeled based on a professional design consistent with the principles of sustainable landscape design.

Stakeholders will be encouraged to nominate a parkway for the project design phase. Parkway must be residential and within the Greater Wilshire as well as Council District 4 boundaries.

Ms. Stromberg invited submissions for this "part two of the program." Mr. Kaliski and Ms. Roberts volunteered to help.
